**SHARED SERVICES AGREEMENT BETWEEN BOROUGH OF LITTLE FERRY**

**And**

**LITTLE FERRY BOARD OF EDUCATION**

**THIS AGREEMENT, made this 10th day of December 2015, by and between:**

**BOROUGH OF LITTLE FERRY, a body politic and corporate of the State of New Jersey, through the Mayor and Council, hereinafter referred to as the "Borough";**

**and**

**THE LITTLE FERRY BOARD OF EDUCATION, a body politic and corporate of the State of New Jersey, hereinafter referred to as "Board of Education."**

**WITNESSETH:**

**WHEREAS, the Borough shall provide a School Resource Officer (SRO) to the Little Ferry Board of Education (hereinafter BOE) for SRO services to be conducted in Memorial and Washington Schools; and**

**WHEREAS, the SRO services cover the BOE school year from July 1, 2015 to June 20, 2016; and**

WHEREAS, the cost to the BOE shall be \$45,000.00 and payable on February 1, 2016; and

WHEREAS, the Little Ferry Police Department has rules and regulations that govern the work of the SRO and these regulation are deemed an exception to the Open Public Records Act (OPRA) as per N.J.S.A 47:1A-1.1(9) and are not available for public consumption and/or review; and

WHEREAS, all parties recognize the purpose of the installation of the cameras on the school properties is to allow the Little Ferry Police Department to monitor the properties from the Little Ferry Police Department headquarters; and

WHEREAS, the parties desire to enter into this Agreement;


**NOW, THEREFORE BE IT RESOLVED THAT THE PARTIES AGREE AS FOLLOWS:**

1. The Borough of Little Ferry and the Little Ferry Board of Education hereby enter into an agreement for the provision of a School Resource Officer and the services said Officer provides to the District; and
2. The agreement shall be in effect from July 1, 2015 to June 30, 2016; and
3. The cost for the SRO services shall be \$45,000.00 and payable on February 1, 2016.

This Agreement shall become effective upon the passing by both parties at their public meetings.
