**SHARED SERVICES AGREEMENT  
BETWEEN  
THE TOWNSHIP OF MEDFORD  
AND  
THE BOROUGH OF MEDFORD LAKES**

This Agreement made this 1st day of March, 2016, between the Township of Medford, having its principal office at 17 N. Main Street, Medford, NJ 08055 (hereinafter "Township"), and the Borough of Medford Lakes, having its principal office at Cabin Circle Drive, Medford Lakes, NJ 08055 (hereinafter "Borough")

**WITNESSETH:**

**WHEREAS**, N.J.S.A. 40A:65-1, et seq. permits a municipality to enter into a contract with any local unit of the State within its jurisdiction for any service which any party to the agreement is empowered to render within its own jurisdiction; and

**WHEREAS**, the Township of Medford employs a paid and volunteer staff of Emergency Medical Technicians. Monday through Friday, during the hours of 6:00 a.m. through 6:00 p.m. are covered by paid staff and the remaining hours are covered by volunteer staff; and

**WHEREAS**, the Borough of Medford Lakes is in need of coverage of providing Emergency Medical Services; and

**WHEREAS**, Medford Township Resolution 58-2016 authorized the execution of this Shared Services Agreement.

**NOW, THEREFORE**, in consideration of the mutual terms, conditions and covenants, it is hereby agreed by and between the parties as follows:

The Township agrees to provide Emergency Medical Services to the Borough of Medford Lakes, provided that the Township has adequate personnel available.

This Agreement shall be in effect for twenty-four (24) months, effective January 1, 2016 and ending on December 31, 2017.

It is an express condition of this Agreement that the provisions herein shall remain in effect pursuant to the Township's ability to provide adequate resources.

The Township of Medford shall indemnify and hold harmless the Borough its officers, employees, agents and servants from and against any and all claims, demands, suits, actions,


recoveries, judgments, costs and expenses, including attorneys' fees, incurred or suffered on account of property damage or loss and/or personal injury, including loss of life, of any person, agency, corporation or governmental entity which shall arise out of the course of or in consequence to any gross negligent acts or omissions of the Township, its employees, agents or servants, in the performance of the work or the failure of the Township, its employees, agents or servants to comply with any term or condition of the agreement.


The Borough shall indemnify and hold harmless the Township of Medford, its officers, employees, agents and servants from and against any and all claims, demands, suits, actions, recoveries, judgments, costs and expenses, including attorneys' fees, incurred or suffered on account of property damage or loss and/or personal injury, including loss of life, of any person, agency, corporation or governmental entity which shall arise out of the course of or in consequence to any gross negligent acts or omissions of the Borough, its employees, agents or servants, in the performance of the work or the failure of the Borough, its employees, agents or servants to comply with any term or condition of the agreement.




