**MUNICIPAL
SHARED SERVICES AGREEMENT**

THIS AGREEMENT, dated 12th day of September, 2017, by and between **TOWNSHIP OF GLOUCESTER**, a municipal corporation of the State of New Jersey, located at Chews Landing road, P.O. Box 8, Blackwood, New Jersey 08012 (hereinafter called "GLOUCESTER TOWNSHIP"), and Cherry Hill Public School District, located at Mahlberg Administration Building, 45 Ranoldo Terrace, Cherry Hill, New Jersey 08034-0391 (hereinafter called "CHERRY HILL PUBLIC SCHOOLS").

WITNESSETH

WHEREAS. The parties desire to enter into a Municipal Services Agreement authorizing Gloucester Township to provide signs to Cherry Hill Public Schools; and

WHEREAS. The parties desire to enter into an agreement memorializing the terms and conditions of the agreement between GLOUCESTER TOWNSHIP and CHERRY HILL PUBLIC SCHOOLS.

NOW THEREFORE, for and in consideration of the signing of this Agreement by the parties, and in further consideration of the terms and covenants of the within Agreement, and the mutual benefits derived by the parties hereto, the parties do hereby agree as follows:

ARTICLE I
AGREEMENT

A. Gloucester Township will provide signs to Cherry Hill Public Schools. The signs will be provided by the Township of Gloucester, Department of Public Works during the term of this agreement. Sign requests shall be scheduled by the respective Municipal Public Works Department Director.

ARTICLE II
TERM

A. This Municipal Shared Services Agreement shall commence on September 12th 2017 and continue for a term until December 31st 2017. The service agreement shall automatically renew for successive twelve month periods thereafter, unless sixty (60) days written notice by either party to the other of the intent to terminate said agreement. Upon receipt of such notice to terminate, this agreement shall expire at the end of the then current term and shall become null and void of no further legal effect.

ARTICLE III
GENERAL CONDITIONS
AND TERMS

A. If any one or more of the terms and provisions of this agreement shall be determined invalid or unenforceable by a Court of Law, the remainder of the terms of provisions thereof shall not be affected thereby and shall continue to be enforceable in all respects.

B. This agreement shall be governed and construed in accordance with the laws of the State of New Jersey.


C. Cherry Hill Public Schools shall pay compensation to Gloucester Township in an amount set for the in Schedule "A" attached, to be paid within 45 days following the Cherry Hill Public School's receipt of a purchase voucher from Gloucester Township.

D. Gloucester Township and Cherry Hill Public Schools may annually approve and adjust as necessary the provisions of this municipal shared service agreement.


E. This agreement may only be amended, modified or changed in a dated writing, executed by Gloucester Township and Cherry Hill Public Schools.

SCHEDULE "A"

1. Cherry Hill Public Schools shall schedule all sign request through the Gloucester Township Department of Public Works.

2. Cherry Hill Public Schools cost to manufacture signs/installation will be based on the current cost of materials and current rate of labor.

3. Township of Gloucester will charge a 20% administrative fee to the total billing.
