RESOLUTION AUTHORIZING THE ENTRY INTO AN INTERLOCAL SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF MONTVILLE AND THE MONTVILLE TOWNSHIP BOARD OF EDUCATION

3/1/15 - 2/29/16

WHEREAS, pursuant to N.J.S.A. 40:8A-1, the Township of Montville may, by Resolution, enter into an Interlocal Services Agreement with another local government entity; and

WHEREAS, the Township of Montville and the Montville Township Board of Education have agreed to enter into an Interlocal Services Agreement to provide for solid waste and recycling collection and disposal from Board of Education owned facilities.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Montville, in the County of Morris, and State of New Jersey, that the appropriate municipal officials are hereby authorized to enter into an Agreement between the Township of Montville and the Montville Township Board of Education for the provision of solid waste and recycling collection and disposal from Board of Education owned facilities for a period of one year at a rate of \$60,000.00 for they year as set forth in the Agreement attached hereto.

INTERLOCAL SERVICE AGREEMENT

THIS AGREEMENT, made this 24th day of February, 2015, by and between the Township of Montville Board of Education, having an address at 86 River Road, Montville, New Jersey 07045 (hereinafter "Board") and the Township of Montville, having an address of 195 Changebridge Road, Montville, New Jersey 07045 (hereinafter "Montville");

WHEREAS, Montville has entered into a contract for the collection and disposal of solid waste and recycling of recyclables; and

WHEREAS, the Board wishes to have Montville take responsibility for the collection and disposal of solid waste and recycling of recyclables generated at Board owned facilities; and

WHEREAS, Montville is willing to accept responsibility for the collection and deposit of solid waste and recycling of recyclables generated at Board owned facilities under its contract for the collection and disposal of solid waste and recycling of recyclables; and

WHEREAS, the governing bodies of Montville and the Board have adopted resolutions pursuant to N.J.S.A. 40A:65-1 et seq., the Interlocal Services Act, authorizing the adoption of this agreement.

NOW, THEREFORE, the parties agree as follows:

1. Montville shall contract with its solid waste hauler to collect and dispose of garbage and recyclable material for Board properties in accordance with the specifications attached hereto as Exhibit A, specifically sections 1-D and 3-B, and one (1) additional 30 yard dumpster to be located at the Board Maintenance Shop.
2. The Board shall pay the Township an annual fixed fee of Sixty Thousand dollars (\$60,000.00) for a term of one year beginning March 1, 2015. The fee shall be paid on a monthly basis and shall be due no later than the tenth day of the month.


