AGREEMENT

THIS AGREEMENT, made by and between the CITY OF VINELAND, hereinafter referred to as "City" and the VINELAND BOARD OF EDUCATION hereinafter referred to as "the BOARD";

WITNESSETH:

WHEREAS, N.J.S.A. 40A:65-4 (Shared Services Act), permits any local unit of the State to enter into a contract with any other local unit or units for the joint provision within their several jurisdictions of any service which any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, the City of Vineland and the Vineland Board of Education provide an Education/Governmental Channel providing the citizens of Vineland with City, Schools and College programs and other vital information; and

WHEREAS, it has become necessary to upgrade the Electronic Message Board because some of the vital electronic equipment is outdated and without technical support and some others have been malfunctioning,; and

WHEREAS, the City and the Board have agreed to a cost-share approach for the upgrade, where the City will pay 50% of the total purchase cost of a Tel Vue System; and


WHEREAS, the Vineland Board of Education has agreed to provide the installation, training and testing of the new system; and

WHEREAS, it is in the best interest of the City of Vineland to enter into an agreement for the purpose of reimbursing the Vineland Board of Education in the amount of \$3,385.00 or 50% of the total cost of \$6,770.00, for the purchase of the Tel Vue System.


NOW, THEREFORE, in consideration of mutual covenants and terms contained herein, the parties hereto agree as follows:

1. The Board agrees to purchase the Tel Vue System, provide the installation, training and testing of the new system.
2. In consideration of said services, the City of Vineland shall reimburse the Vineland Board of Education, in the amount of \$3,385.00 or 50% of the total cost of \$6,770.00.
3. All requests for reimbursement must be in accordance with City Ordinance 1048, incorporated herein by reference.
4. This agreement shall be conditioned upon approval of authorizing resolutions being passed by the City and the Board.




