AGREEMENT

BY AND BETWEEN the Borough of Ringwood, a municipal corporation of the County of Passaic, State of New Jersey, having its principal office 60 Margaret King Avenue, Ringwood, NJ.

AND the Borough of Bloomingdale, a municipal corporation of the County of Passaic, State of New Jersey, having its principal office at 101 Paterson-Hamburg Turnpike, Bloomingdale, NJ.

WITNESSETH

The Borough of Ringwood (hereinafter "Ringwood") and the Borough of Bloomingdale (hereinafter "Bloomingdale") have agreed that the citizens for their respective communities can be better served, at a reduced expenditure, by arranging for joint provision of certain governmental services as permitted by N.J.S.A. 40:8A-1 et seq.

IT IS THEREFORE AGREED AS FOLLOWS:

Terms of Agreement. This Interlocal Service Agreement ("Agreement") shall be effective from January 1, 2017 through December 31, 2019.

Scope of Services. Snake Den Road, a public street of Bloomingdale is not directly connected to or directly accessible from the balance of the Bloomingdale system. Snake Den Road is accessible from and connection to that portion of Snake Den Road in Ringwood.

Ringwood shall furnish the following services to Bloomingdale residents who reside on Snake Den Road:

Police protection
Fire services
Ambulance services

Garbage/Recycling collection
Snow plowing

Ringwood Police, volunteer fire and ambulance corps shall act as your mutual aid provider.

Fees. In consideration of this service, Bloomingdale shall, in the first year (2017), pay **\$36,602**. During the second year of this Agreement and each successive year thereafter, Ringwood reserves the right to increase the amount paid by Bloomingdale in an amount not to exceed 5%.

Bloomingdale shall provide sufficient funds in its budget to cover contract costs. Bloomingdale shall provide yearly payment by October 31 for said Agreement for the duration of the Agreement.

Termination. This Agreement may be terminated by either party on 60 days written notice to the other party at the business addresses set forth below.




