


**AMBULANCE SERVICE AGREEMENT  
BETWEEN  
EGG HARBOR CITY AND THE GALLOWAY TOWNSHIP AMBULANCE SQUAD, INC**

It is agreed by and between the City of Egg Harbor whose mailing address is 500 London Avenue, Egg Harbor City, New Jersey and the Galloway Township Ambulance Squad Incorporated, a non-profit corporation located at 311 Carton Avenue whose mailing address is Post Office Box 784 Pomona New Jersey, in consideration of the mutual covenants and conditions contained herein as follows:


1. The Galloway Township Ambulance Squad Inc. shall provide to the City of Egg Harbor and all of the residents and visitors to the City of Egg Harbor, ambulance service which shall be provided in a reliable and professional manner, based on availability of crew and mutual aid.
2. The coverage area is defined as all locations within the borders of the City of Egg Harbor.
3. The ambulance services provided shall be available on an availability basis twenty-four (24) hours a day seven (7) days a week unless otherwise notified during the term of this contract, barring any situation or occurrence not under the control of the Galloway Township Ambulance Squad. Ambulances will be staff and stationed at the Galloway Township Ambulance Squad Building.
4. All services shall be performed in accordance with acceptable State of New Jersey standards and practices.
5. The City of Egg Harbor will pay the sum of \$15,000 per year in quarterly payments of \$3,750 on, January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup>, and October 1<sup>st</sup>. The amount of this fee may be evaluated and or modified on an annual basis.
6. The Township of Galloway Ambulance Squad Inc, shall be permitted to establish a fee schedule for cost recovery in order to bill for emergency medical services to the residents and visitors of the of the City of Egg Harbor. Any funds collected shall be for the benefit of the Galloway Township Ambulance Squad.
7. The term of this contract shall be from and commence on January 1, 2016 and shall continue through December 31, 2016, and may be extended by written agreement of the parties. Cancellation of this contract is subject to ninety (90) day written notice by either party.
8. The laws of the State of New Jersey shall govern the terms of this contract.
9. The Galloway Township Ambulance Squad shall be responsible for the training of its personnel according to OSHA, PEOSHA and other state and federal regulations. The Galloway Township Ambulance Squad shall provide normal ambulance equipment and supplies for the ambulance. All ambulances used for primary response to Egg Harbor City shall be inspected and licensed by the New Jersey Department of Health, and shall be capable of providing EMT-Defibrillation level service.
10. This agreement may not be altered, modified, or amended except in writing properly executed by the parties hereto.
11. The City of Egg Harbor shall be responsible for notifying the appropriate law enforcement agency and dispatch agency of this agreement.
12. The Galloway Township Ambulance Squad will provide to the City of Egg Harbor the appropriate Certificates of Insurances providing evidence of Workers' Compensation, Employer's Liability, Commercial General Liability, and Automobile coverage. The City of Egg Harbor shall be included as an Additional Insured on the insurance coverage.
13. The City of Egg Harbor City will provide to the Galloway Township Ambulance Squad the Appropriate Certificates of Insurances providing evidence of Workers' Compensation, Employer's Liability, Commercial General Liability, and Automobile coverage.
14. Egg Harbor City agrees that it shall hold the Galloway Township Ambulance Squad harmless from any and all liability and claims for damages or injury caused by or resulting from the negligent acts, errors or omissions of Egg Harbor City or Egg Harbor City's agents, officers, employees or assigns, arising out of the provision of the services set forth in this Agreement and the Galloway Township Ambulance Squad agrees that it shall indemnify and hold Egg Harbor City harmless from any and all liability and claims for damages or injury caused by or resulting from the negligent acts, errors or omissions of the Galloway Township Ambulance Squad or the Galloway Township Ambulance

Squad's agents, officers, employees or assigns, arising out of the provision of the services set forth in this Agreement.

IN WITNESS WHEREOF, the parties have caused their appropriate officials and officers to sign this agreement on the 28<sup>th</sup> day of December 2015.
