AN ORDINANCE OF THE TOWNSHIP OF EVESHAM AMENDING
CHAPTER 72 OF THE CODE OF THE TOWNSHIP OF EVESHAM

BE IT ORDAINED by the Township Council of the Township of Evesham, County of Burlington, State of New Jersey as follows:

SECTION I. Chapter 72 of the Code of the Township of Evesham is hereby amended to read as follows:

- (c) No refunds of fees will be made after a program or class has commenced.

 - (c) Truck tire \$5
 - (d) Truck tire with rim \$5.50
- (2) Automated containers
 - (a) 95 - gallon \$50
 - (b) 65 - gallon \$40


SECTION II. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.


SECTION III. If any part of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portion of the ordinance.
