ORDINANCE NO. 1203 (1998)

AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF SEA ISLE CITY, CHAPTER 3, SECTION 4, ENTITLED "NOISE" TO ESTABLISH THE NOISE FREE ZONES IN THE CITY OF SEA ISLE CITY IN WHICH THERE WILL BE ENHANCED PENALTIES FOR VIOLATIONS OF NOISE REGULATIONS.

WHEREAS, the Board of Commissioners has in the past found excessive sound and vibration a serious hazard to the public health and welfare, safety, and the quality of life; and,

WHEREAS, the residents and visitors of the City of Sea Isle City are entitled to an environment free from excessive sound and vibration that may jeopardize their health or welfare or safety, or otherwise degrade the quality of life; and,

WHEREAS, it is the policy of the City of Sea Isle City to prevent excessive sound and vibration which may jeopardize the health or welfare or safety or its citizens and visitors, or degrade the quality of life and the quiet enjoyment of property;

WHEREAS, the City of Sea Isle City has adopted Ordinance No. 1199 (1998) which creates the enhanced penalties in noise free zones;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS of the City of Sea Isle City, County of Cape May and State of New Jersey as follows:

SECTION I. Section 3-4.8, entitled "Prohibited Acts", is amended to add the following schedule of noise free zone locations to subsection 3-4.8(c);

Schedule A

37th Street	Central Avenue to Cini Street
38th Street	Central Avenue to Kneass Street
39th Street	Landis Avenue to Kneass Street
40th Street	Landis Avenue to Central Avenue
46th Street	Landis Avenue to Central Avenue
49th Street	Landis Avenue to Central Avenue
56th Street	Sounds Avenue to Roberts Avenue
88th Street	Landis Avenue to Bay


SECTION III. Severability If for any reason any section of this Ordinance shall be declared illegal by any Court of competent jurisdiction, the remaining section of the Ordinance shall remain in full force and effect notwithstanding.


SECTION IV. Repealer. Any Ordinance or provision thereof inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.


SECTION V. Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.
