

BOROUGH OF MANASQUAN
ORDINANCE NO. 1977-06

AN ORDINANCE TO AMEND AND SUPPLEMENT SECTION 35-14.2 (SENIOR CITIZEN HOUSING) OF CHAPTER 35 (ZONING) TO ESTABLISH REGULATIONS FOR PLANNED MULTI-FAMILY HOUSING FOR SENIOR CITIZENS IN THE BOROUGH OF MANASQUAN, MONMOUTH COUNTY, NEW JERSEY.

BE IT ORDAINED, by the Borough Council of the Borough of Manasquan, in the County of Monmouth and State of New Jersey, as follows:

Section 1. Section 35-14.2 (Senior Citizen Housing) of Chapter 35 (Zoning) of the Code of the Borough of Manasquan is amended and supplemented as follows:

- a. *Permitted Uses:* planned multifamily housing for senior citizens.
- b. *Minimum Lot Area:* twenty-two thousand (22,000) square feet.
- c. *Minimum Frontage:* one hundred (100) feet.
- d. *Front Yard Setback:* thirty (30) feet.
- e. *Rear Yard Setback:* thirty-five (35) feet.
- f. *Side Yard Setback:* five (5) feet.
- g. *Perimeter Landscape Setback:* fifteen (15) feet landscaped with a variety of plantings to create a year-round buffer.
- h. *Maximum Building Coverage Area:* thirty (30%) percent.
- i. *Maximum Lot Coverage Area:* forty-five (45%) percent.
- j. *Building Height:* two (2) stories not to exceed twenty-eight (28) feet.
- k. *Maximum Density:* one (1) unit per four thousand (4,000) square feet.
- l. *Off-Street Parking:* to be in accordance with site improvement standards promulgated by the State of New Jersey.
- m. *Senior Citizen* means a person fifty-five (55) years of older. A person under the age of fifty-five (55) may reside in a

Senior Citizen Housing Complex provided that his or her spouse is fifty-five (55) years of age or older.

Section 2. If any part or parts of this ordinance are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this ordinance.

Section 3. All ordinances or parts of ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency. All other parts of Chapter 35 of the Code of the Borough of Manasquan not inconsistent herewith are ratified and confirmed.

Section 4. This ordinance shall become effective following its final passage and publication as required by law.
