

TOWNSHIP OF EVESHAM

ORDINANCE NO. 24-9-2004

**AMENDING CHAPTER 150 OF THE TOWNSHIP
CODE ENTITLED "VEHICLES AND TRAFFIC"
(BRIARWOOD DEVELOPMENT)**

WHEREAS, the Township Council of the Township of Evesham previously passed Ordinance No. 7-3-97, making the provisions of Title 39 governing traffic regulations applicable to the roads of the Briarwood development prior to dedication; and

WHEREAS, the Township Council of the Township of Evesham has released the performance bonds with regard to said roads and has thereby accepted same; and

WHEREAS, the Township Code needs to be amended to properly reflect the status of these roads and the regulations affecting same.

NOW, THEREFOR, BE IT ORDAINED by the Township Council of the Township of Evesham, that Chapter 150, "Vehicles and Traffic", be amended as follows:

Section 1. Chapter 150-31.5, "Briarwood", is hereby deleted.

Section 2. Chapter 150-38, "Schedule VII: Through Streets", is hereby amended by adding the following streets:

Continental Lane	Entire Length
Country Squire Lane	Entire Length
Old Republic Lane	Entire Length
Washington Drive	Entire Length

Section 3. Chapter 150-39, "Schedule VIII: Stop Intersections", is hereby amended by adding the following intersections:

<u>Intersection</u>	<u>Stop Sign(s) On</u>
Patrick Henry Drive and Tory Lane	Tory Lane
Wayne Drive and Tory Lane	Wayne Drive
Wayne Drive and Tide Water Lane	Tide Water Lane

Section 4. Chapter 150-48, "Schedule XVII: Speed Limits", is hereby amended by adding the following designations:

<u>Name of Street</u>	<u>Speed Limit</u>	<u>Location</u>
Continental Lane	25	Entire Length
Country Squire Lane	25	Entire Length
Light Horse Court	25	Entire Length
Loyalist Court	25	Entire Length
Old Republic Lane	25	Entire Length
Patrick Henry Drive	25	Entire Length
Tide Water Lane	25	Entire Length
Tory Lane	25	Entire Length
Washington Drive	25	Entire Length
Wayne Drive	25	Entire Length

Section 5. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 6. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

Section 7. This ordinance shall take effect immediately upon due passage and publication according to law.

Section 8. A certified copy of this ordinance shall be transmitted to the Commissioner of Transportation within thirty (30) days of its adoption.
