

AMENDMENT TO SHARED SERVICES AGREEMENT

An AMENDMENT was entered into on the 9th day of APRIL 2014, to THE SHARED SERVICES AGREEMENT entered into on the 17th day of June, 2008 by and between:

THE TOWNSHIP OF MARLBORO a municipal corporation of the State of New Jersey, with offices located at 1979 Township Drive, Marlboro, New Jersey 07746-2299; and,

THE TOWNSHIP OF MANALAPAN, a municipal corporation of the State of New Jersey with offices located at 120 Route 522 & Taylors Mills Road, Manalapan, New Jersey 07726, hereinafter referred to as the "Parties".

WITNESSETH

This document shall serve as a REVISION TO THE AMENDMENT

Section B: Use by the Manalapan Summer Camp Program, Paragraph #5 for the Summer 2014 Season:

"The Township of Manalapan shall pay to the Township of Marlboro \$5 per child/per day for the first forty children that arrive in the first hour (between 9am and 10 am) of camp each day. For each child in excess of forty children that arrive in the first hour of camp each day, the Township of Manalapan shall pay the Township of Marlboro \$2.50 per child/per day. A maximum of 100 children shall be permitted between 9am and 10am, Monday through Friday. The Township of Manalapan shall pay the Township of Marlboro at the rate of \$5 per child/per day for each child that arrives at camp between 10am and 11am, Monday through Friday. A maximum of forty (40) children shall be permitted between 10am and 11am.

However, notwithstanding anything contained herein to the Agreement, the annual payment associated with the within Agreement shall not exceed \$17,500.00 (Seventeen Thousand Five Hundred Dollars)."

This document shall remain in full force and effect until the expiration of said Shared Services Agreement.

Beginning with memberships for the 2012 season, the fee increases approved for Marlboro Resident Swim Club memberships (on a percentage basis) shall be applied to Manalapan Non-Resident memberships.
