**RESOLUTION APPROVING A SHARED SERVICES AGREEMENT  
FOR ANIMAL CONTROL SERVICES WITH THE BOROUGH OF  
FANWOOD FOR 2014**

**WHEREAS**, as a result of the closing and termination of animal control services by the Union County Society for the Prevention of Cruelty to Animals the Borough of Fanwood has requested to enter into a Shared Services Agreement with the City of Linden; and

**WHEREAS**, it is in the best interests of the health, safety and welfare of the citizenry that the City of Linden provide such services; and

**WHEREAS**, the Borough of Fanwood has indicated its willingness to enter into said agreement and share such costs and services as aforesaid;

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF LINDEN** that the Mayor and City Clerk be and hereby are directed and authorized to execute a Shared Services Agreement with the Borough of Fanwood wherein said services will be provided, and wherein it shall be reflected that the Borough of Fanwood will pay the City of Linden a charge of \$950.00 per month, in monthly installments, payable on or before the first day of each month to the Municipal Treasurer, commencing January 1, 2014 and terminating December 31, 2014; and


**BE IT FURTHER RESOLVED** that a duly executed copy of this Resolution be forwarded to the Clerk of the Borough of Fanwood; and

**RESOLUTION APPROVING A SHARED SERVICE AGREEMENT FOR  
SOLID WASTE SERVICES INVOLVING BULKY WASTE - TYPE 13  
AND VEGETATIVE WASTE - TYPE 23 WITH THE PLAINFIELD MUNICIPAL  
UTILITIES AUTHORITY**

**WHEREAS**, the City of Linden, and the Plainfield Municipal Utilities Authority desire to enter into a Shard Service Agreement in the form attached hereto as Exhibit A whereby the Authority will provide the City with certain solid waste services with respect to Bulky Waste Type 13 and Vegetative Waste Type 23, generated within the City; and

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. authorizes the Parties to enter into an agreement for such shared or consolidated solid waste services.

**WHEREAS**, the Council has determined that said agreement is in the best interest of the City to enter into such Shard Service Agreement.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Linden as follows:

1. The Mayor and/or such other officials as necessary and proper or are hereby authorized to execute the Shard Service Agreement between the Plainfield Municipal Utilities Authority and the City of Linden in the form attached hereto as Exhibit A, subject to final approval as to form and legal content by the City Attorney, and the City Clerk is hereby authorized to attest to same and to affix the City's seal thereon.
2. This Resolution hereby amends and supersedes all prior Resolutions that are inconsistent herewith.
3. This Resolution all shall take effect immediately.




