
WHEREAS, pursuant to the Uniform Shared Services Act, N.J.S.A. 40A:65-1 et seq., any municipality of the State may enter into a contract for the joint provision of any service that any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, the Township of Tabernacle is in need of the procurement of identification badges for essential employees and desires to enter into a Shared Services Agreement with the Township of Evesham for the same; and

WHEREAS, the parties have negotiated a form of Shared Service Agreement, a copy of which is attached hereto and incorporated herein by reference; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Evesham, County of Burlington and State of New Jersey, that the Mayor and Township Clerk be and are hereby authorized to execute the Shared Services Agreement with the Township of Tabernacle for the provision of identification badges for essential employees of Tabernacle Township.

**SHARED SERVICE AGREEMENT FOR THE PROVISION OF IDENTIFICATION BADGES FOR
TABERNACLE TOWNSHIP ESSENTIAL EMPLOYEES**

THIS AGREEMENT is entered into this 13 day of June, 2016 between the Township of Tabernacle, a Municipal Corporation of the State of New Jersey with offices located at 163 Carranza Road, Tabernacle, NJ 08088 hereinafter referred to as "TABERNACLE"; and

The Township of Evesham, a Municipal Corporation of the State of New Jersey located at 984 Tuckerton Road, Evesham, NJ 08053 hereinafter referred to as "EVESHAM".

WHEREAS, pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et. Seq., TABERNACLE and EVESHAM are desirous of entering into a Shared Service Agreement for the provision of identification badges for Tabernacle Township essential employees; and

WHEREAS, Tabernacle Township is in need of the procurement of identification badges for the Township's essential employees and the Township of Evesham has agreed to procure same on behalf of the Township of Tabernacle.


NOW THEREFORE, TABERNACLE and EVESHAM agree as follows:


1. EVESHAM will provide TABERNACLE with all essential employees' identification badges, including said badges for the Mayor and Governing Body members for THREE DOLLARS (\$3.00) per badge.
2. This service shall include issuance of a new identification badge in accordance with the annual changes associated with Committee appointments and for any and all newly hired employees.
3. The initial term of this Agreement shall be for a period of five (5) years beginning on July 1, 2016 and terminating on June 30, 2021.
4. Either party to this Agreement may terminate their duties and obligations hereunder by notifying the other party of their intention to terminate the Agreement in writing no less than sixty (60) days prior to termination.
5. This Agreement may be amended at any time by mutual agreement of the parties, provided that such amendment is reduced to writing and executed by the Township Manager and Township Administrator or his/her designated representative.


