

SHARED SERVICE AGREEMENT

**BETWEEN
THE CITY OF TRENTON
AND
COUNTY OF MERCER**

**CITY MATCH FOR TRENTON MUNICIPAL ALLIANCE GRANT
July 1, 2017-June 30, 2018**

THIS AGREEMENT is made this 10th day of August 2017, by and between the City of Trenton, 318 East State Street, Trenton, NJ (hereafter referred to as "City") and the County of Mercer (hereinafter referred to as "County").

WHEREAS, pursuant to the authority of N.J.S.A. 40A:65-1, et seq., the County and City have agreed to have Mercer County, Office on Addiction Services, and for said services to be arranged for the City by the County for a time period of one year from date of Agreement; and,

WHEREAS, it is understood that the County is entering into this Shared Service Agreement in an effort to maximize benefits and improve municipal and county prevention and education services within the Trenton Municipal Alliance Program in the City of Trenton; and,

WHEREAS, the County will contract with a community organization to provide prevention education services on behalf of the City; and,

WHEREAS, the County is utilizing a competitive contracting process to select a qualified community agency to perform prevention education and Alliance activities on behalf of the City of Trenton; and,

WHEREAS, the County will oversee the contract compliance of said agency on both a programmatic and fiscal level; and,

WHEREAS, it is required by the State of New Jersey's Governor's Council on Alcohol and Drug Abuse (GCADA) to provide a 25% City match of Drug Enforcement Demand Reduction (DEDR) Funds for a total of \$31,609.25 for the one year period; and,

WHEREAS, the City accepts full responsibility in providing the City match of funds totaling \$31,609.25 to be paid in one lump sum; and,

WHEREAS, the City will identify and appoint community representatives to the Trenton Municipal Alliance Committee as outlined in the Municipal Alliance Program Guidelines promulgated by GCADA; and,

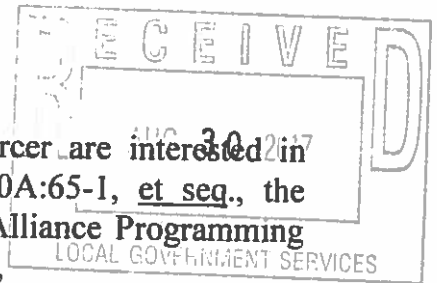

WHEREAS, it is understood that the County of Mercer and the City of Trenton are entering into this Agreement in an effort to maximize benefits and improve municipal and county drug and alcohol prevention and education; and,

WHEREAS, pursuant to the authority of N.J.S.A. 40A:65-1, et seq., the County of Mercer and the City of Trenton have agreed to have the Mercer County Office of Addiction Services provide drug and alcohol prevention and education programming; and,

WHEREAS, funds for this purpose are available in the 2017 Mercer County Budget and are contingent upon the inclusion and the adoption of the 2018 Mercer County Budget; and,


WHEREAS, the source of funding for this Shared Services Agreement comes to the County as a 25% percent cash match of the Trenton allocation of DEDR funds (Drug Enforcement Demand Reduction [DEDR] assessments, which have passed through the Governor's Council on Alcoholism and Drug Abuse for the purpose of providing education programs at the local level; and,

WHEREAS, the County of Mercer entered into a Competitive Contract with the Mercer Council on Alcoholism and Drug Addiction (MCADA) for the Trenton Municipal Alliance Program in the amount of \$158,046.25 (\$126,437.00 - State DEDR Funds; \$31,609.25 - City of Trenton cash match) for the period of July 1, 2016 through June 30, 2017, with two (2) one year options to extend, as per Resolution No. 2016-299, adopted June 23, 2016; and,

WHEREAS, in exchange for receiving the within service, the City of Trenton agrees to indemnify and hold harmless the County of Mercer for any liabilities which may arise out of using the services provided by the County's Office on Addiction Services; now, therefore;

BE IT RESOLVED, that:

1. The County Executive and Clerk to the Board are hereby authorized to execute a Shared Services Agreement with the City of Trenton for Municipal Alliance programming for the provision of drug and alcohol education and prevention programs, for the period of July 1, 2017 through June 30, 2018, in an amount of \$31,609.25 (City Match Funds).
