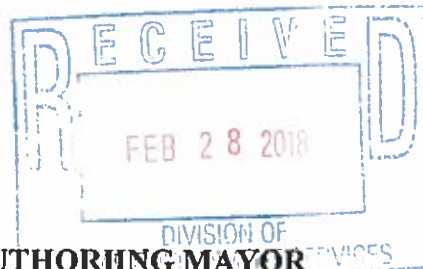

RESOLUTION REVISING RESOLUTION R-366-2017 AUTHORIZING MAYOR WESTFALL TO SIGN SHARE SERVICE AGREEMENT WITH THE UPPER FREEHOLD REGIONAL SCHOOL DISTRICT FOR CROSSING GUARD SERVICES FOR 2017-2018

Whereas, the Borough of Allentown and the Upper Freehold Regional School District have entered into multiple shared service agreements for Crossing Guard services over the years; and

Whereas, both parties would like that arrangement to continue for the 2017-2018 school year; and

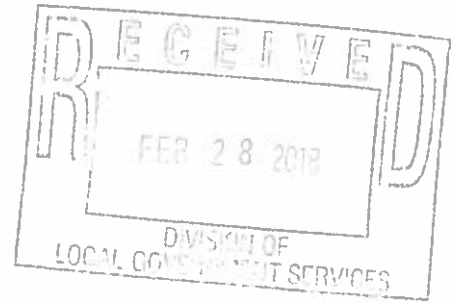

4. A copy of this resolution will be sent to the Upper Freehold Regional School District, Chief Financial Officer and Municipal Clerk.



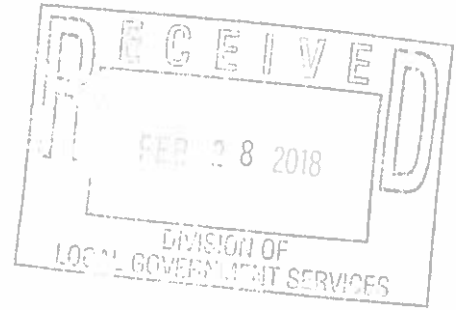


