SHARED SERVICES AGREEMENT

This Agreement is made on this 23rd day of May, 2017 by and between the **COUNTY OF CUMBERLAND**, a body corporate and politic of the State of New Jersey, whose address is 164 West Broad Street, Bridgeton, NJ 08302 (hereinafter "**CUMBERLAND**") and the **CITY OF BRIDGETON**, a public body corporate and politic of the State of New Jersey, whose address is 181 E. Commerce Street, Bridgeton, NJ 08302 (hereinafter "**BRIDGETON**").

WITNESSETH:

WHEREAS, the public zoo operated by the City of Bridgeton provides recreational and educational opportunities for all Cumberland County residents; and

WHEREAS, the County of Cumberland has a tradition of providing financial assistance to the City of Bridgeton towards the cost of operation of the Cohanzick Zoo; and

WHEREAS, parties acknowledge the importance to the public of the continuing operation of the Cohanzick Zoo; and

WHEREAS, the "Uniform Shared Services and Consolidation Act" (N.J.S.A. 40:65A-1 et seq.) provides that local units of government may enter into a contract for the joint provision of any service which either party to said agreement is empowered to render or perform within its own jurisdiction;

NOW, THEREFORE, in consideration of the mutual promises contained herein, and for other good and valuable consideration, the parties agree as follows:


1. All of the above recitals are incorporated herein by reference as if repeated at length..
2. **CUMBERLAND** shall appropriate the amount of **TWENTY THOUSAND (\$20,000.00) DOLLARS** to the City of Bridgeton for the period January 1, 2017 through December 31, 2017, towards the cost of the operation of the Cohanzick Zoo.
3. **BRIDGETON** agrees to utilize said appropriated funds from **CUMBERLAND** towards the operation of the Cohanzick Zoo which shall continue to provide recreational opportunities for all Cumberland County residents.
4. The parties hereto recognize and expressly state that the Cohanzick Zoo is not owned, operated or maintained by **CUMBERLAND**.
5. It is further recognized and agreed by the parties that employees of the Cohanzick Zoo are not agents, servants or employees of **CUMBERLAND**.

6. CUMBERLAND also agrees to forgive BRIDGETON in the amount of TEN THOUSAND (\$10,000.00) DOLLARS owed by BRIDGETON to CUMBERLAND with respect to payments due and owing from the replacement of water main facilities at Sunset Lake.


7. Bridgeton agrees to abide by the regulations of P.L. 1975, Chapter 127, Affirmative Action as described in Schedule A.





**RESOLUTION AUTHORIZING SHARED SERVICES AGREEMENT
WITH THE CITY OF BRIDGETON (COHANZICK ZOO) (\$20,000.00)**

WHEREAS, the Cohanzick Zoo, which is operated by the City of Bridgeton, provides recreational and educational opportunities for all County residents; and

WHEREAS, the County of Cumberland has a tradition of providing financial assistance to the City of Bridgeton for the operation of the Cohanzick Zoo; and

WHEREAS, the Finance Committee has recommended that the County provide funding in the amount of \$20,000.00 to the City of Bridgeton for the period January 1, 2017 through December 31, 2017 in return for the City of Bridgeton's providing recreational opportunities for all County residents through operation of the Cohanzick Zoo; and

WHEREAS, the Uniform Shared Services and Consolidation Act (N.J.S.A. 40:65-1 et seq.) provides that local units of government may enter into a contract for the joint provision of any service which either party to said agreement is empowered to render or perform within its own jurisdiction; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That the agreement between the City of Bridgeton and the County of Cumberland for providing financial assistance by the County to the City of Bridgeton for the City of Bridgeton providing recreational opportunities through operation of the Cohanzick Zoo as set forth in the preamble to this resolution, is hereby approved in the form on file with the Clerk of

this Board.

2. That said funds shall be charged to Line Item Appropriation or Account No. 7-01-29-795-202-707 in the amount of \$20,000.00.

RESOLUTION AUTHORIZING SHARED SERVICE AGREEMENT
BETWEEN COUNTY OF CUMBERLAND AND
CITY OF BRIDGETON REGARDING COHANZICK ZOO

WHEREAS, the City of Bridgeton operates a public zoo providing recreational and educational opportunities for residents of Bridgeton and the County of Cumberland; and

WHEREAS, the County of Cumberland has agreed to provide financial assistance to the City of Bridgeton toward the cost of the Cohanzick Zoo; and

WHEREAS, the County of Cumberland has agreed to provide \$20,000 to the City of Bridgeton for the aforesaid purpose from January 1, 2017 through December 31, 2017 pursuant to a shared services agreement; and

WHEREAS, a shared services agreement with respect to the receipt and expenditure of the aforesaid funds has been requested by the County of Cumberland incorporating the terms and conditions of the receipt and use of said funds; and

WHEREAS, the City Council of the City of Bridgeton is desirous of authorizing the agreement and the receipt of funds in connection therewith; and


WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40:65A-1, et seq. allows local governmental units to enter into shared service agreements for any purpose for which each of the units could otherwise appropriately act; and

WHEREAS, the City Council of the City of Bridgeton is desirous of authorizing execution of the aforesaid agreement;


NOW THEREFORE BE IT RESOLVED by the City Council of the City of Bridgeton that the Mayor and Clerk be and are hereby authorized and directed to enter into a shared service agreement with the County of Cumberland authorizing the receipt of \$20,000 for the period January 1, 2017, through December 31, 2017, Cohanzick Zoo toward the cost of the operation of the Cohanzick Zoo, subject to and according to the terms and conditions of a shared services agreement.


