

AGREEMENT

In accordance with N.J.S.A. 40A:65-1 et seq., the Uniformed Shared Services and Consolidation Act, the Township of Lyndhurst, Bergen County and the Borough of Wanaque, Passaic County herein agree to the following terms and conditions and say that:

THIS AGREEMENT, is made the 1st day of April, 2013 by and between the Township of Lyndhurst, a municipal corporation of the State of New Jersey, hereinafter referred to as "Receiver", and the Borough of Wanaque, a municipal corporation of the State of New Jersey, hereinafter referred to as "Provider";

WITNESSETH

WHEREAS, this Agreement, pursuant to N.J.S.A. 40A:65-1 et seq., shall be for the purpose of providing recreation registration services by Wanaque to Lyndhurst so as to permit the Township of Lyndhurst to have an appropriate means of accepting electronic, including on-line recreation program registration and credit card processing of recreation fees so as to improve public accessibility of Lyndhurst recreation programs; and

WHEREAS, the Township of Lyndhurst desires to pay the Borough of Wanaque for said recreation registration services; and

WHEREAS, the Borough of Wanaque desires to provide said services through it's QPA, Tom Carroll, to Lyndhurst so as to provide efficient government services and continue the both the Township's and Borough's effort of providing the highest quality of administrative services.

NOW THEREFORE, in consideration of the foregoing and subject to the terms and conditions of the following, the parties hereto agree as follows:

1. The Provider's QPA is authorized to implement electronic recreation registration services together with the Lyndhurst recreation department.
2. The duly licensed QPA shall carry out, supervise and direct all electronic registration activities with the Township of Lyndhurst recreation department, finance department and other departments and offices of the Receiver.

3. The Receiver shall indemnify and hold harmless the Provider, and by extension, the QPA, from any registration errors processed, by the Receiver.

It is further Agreed that:

4. This Agreement shall cover the provision of recreation registration services, described herein, for the three year period of April 1, 2013 to March 31, 2016. However, either party may terminate this Agreement on March 31, 2014 with a minimum five days notice to the other party. After April 1, 2014 either party may terminate this Agreement upon furnishing the other party with a minimum of sixty (60) days notice, provided that all fees are paid as required herein.

5. The Receiver shall pay the Provider the annual sum of \$10,000 for said electronic recreation registration services. This inter local services fee shall be paid annually on or about June 1 of each year this agreement is in effect.

The parties hereto agree to be bound by the provisions of this Agreement and shall deal fairly with the other in all matters relating to this Agreement.

RESOLUTION OF THE TOWNSHIP OF LYNDHURST, IN THE COUNTY OF BERGEN, AUTHORIZING A SHARED SERVICES AGREEMENT WITH THE BOROUGH OF WANAUKE, IN THE COUNTY OF PASSAIC, FOR THE PROVISION OF COMPUTERIZATION SERVICES OF RECREATION FEES

WHEREAS, the Township of Lyndhurst, has been in discussions to share various services so as to mutually and respectively reduce the cost of providing such municipal services between the Township and a providing or receiving municipality; and

WHEREAS, the Township needs a computerization service to collect recreation fees to ease the process of registrations and collection of fees for recreation programs; and

WHEREAS, the Borough of Wanauke has contracted with a company to perform such services; and

WHEREAS, the Lyndhurst Board of Commissioners finds that it is the public interest to enter a shared service Agreement with the Borough of Wanauke for the use of these computer services, pursuant to the provisions of N.J.S.A. 40A:65-1 et seq., the Uniformed Shared Services and Consolidation Act.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF the Township of Lyndhurst that the Mayor and Commissioner of Finance are hereby authorized to execute an Agreement with the Borough of Wanauke for the use of the computerized services for the recreation program fees by the Township of Lyndhurst.
