A RESOLUTION AUTHORIZING AND APPROVING A SHARED SERVICES AGREEMENT FOR AUTOMOTIVE SERVICES BETWEEN THE ROBBINSVILLE TOWNSHIP BOARD OF EDUCATION AND THE TOWNSHIP OF ROBBINSVILLE

WHEREAS, the Robbinsville Township Board of Education desires to contract with the Township of Robbinsville for the provision of automotive services to the Robbinsville Township Board of Education for the period of January 1, 2018 to December 31, 2018; and

WHEREAS, the Township of Robbinsville has agreed to provide automotive services to the Robbinsville Township Board of Education at the following rates:

- a. Labor rate of \$ 63.67 per man hour
- b. 10% over Township cost for all repair parts and sublet parts. No charge will be made for parts which are supplied by the Robbinsville Township Board of Education.
- c. The BOE will be billed for salt usage at \$87.75 per ton, and \$63.67 per hour for Salt Truck w/ driver. A typical salting event would require 3 tons of salt and one hour.

WHEREAS, such agreements are authorized pursuant to the Uniform Shared Services Consolidation Act, N.J.S.A. 40A:65-1 et. seq.; and

WHEREAS, this agreement is in the best interest of the Township of Robbinsville.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Robbinsville, in the County of Mercer and State of New Jersey, that the Shared Services Agreement between the Robbinsville Township Board of Education and the Township of Robbinsville for the provision of automotive services is authorized and accepted and the proper officials of the Township of Robbinsville are authorized to execute said agreement.

BE IT FURTHER RESOLVED that the agreement shall take effect upon the execution of agreement by the parties in accordance with N.J.S.A. 40A:65-5(c), et seq.

BE IT FURTHER RESOLVED that a copy of this resolution and agreement shall be forwarded to the Director of the Division of Local Government Services as per NJSA 40A:65-4 (3)b.

BE IT FURTHER RESOLVED that a copy of this resolution shall be forwarded to the Chief Financial Officer, the Director of Public Works, and the Robbinsville Township Board of Education.

SHARED SERVICE AGREEMENT BETWEEN ROBBINSVILLE TOWNSHIP AND THE
ROBBINSVILLE TOWNSHIP BOARD OF EDUCATION

THIS SHARED SERVICE AGREEMENT is effective January 1, 2018, between the TOWNSHIP OF ROBBINSVILLE, a municipal corporation of the State of New Jersey, 1 Washington Blvd., Robbinsville, NJ, hereinafter referred to as "Township" and the ROBBINSVILLE TOWNSHIP BOARD OF EDUCATION, 155 Robbinsville-Edinburg Rd., Robbinsville, NJ, hereinafter referred to as "BOE".

Witnesseth that:

Whereas, the BOE desires to contract with the Township of Robbinsville for the provision of automotive repair services for the BOE's vehicles and equipment; and

Whereas, the Township of Robbinsville is agreeable to providing automotive repair services to the BOE for a fee and certain specified conditions; and

Whereas, the *Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq.*, permits local units of this State to enter into a contract with any other local unit for the joint provisions within their combined jurisdictions of any service which any party to the agreement is empowered to render within its jurisdiction; and

Whereas, the Township of Robbinsville and the BOE have authorized and approved of this Agreement by resolution duly adopted pursuant to *N.J.S.A. 40A:65-5 of the Uniform Shared Services Consolidation Act*;

Now, Therefore, in consideration of the mutual agreements and covenants contained herein, the parties hereto agree as follows:

1. **Term.** This Agreement shall take effect January 1, 2018 and expire December 31, 2018.
2. **Scope of Services.** The Township shall provide automotive services to the BOE according to the terms and conditions set forth below:
 - a. No vehicle/equipment repair in excess of \$750.00 shall be made by the Township unless specifically authorized by the designated the BOE representative.
 - b. The BOE shall designate one (1) person and one (1) back up person to schedule and be responsible for authorization on all repairs.
 - c. Minor road calls shall be performed by the Township during normal working hours and the hourly rate provided in 3a below, provided manpower and equipment is available and not being utilized in servicing / repair of Township vehicles.

d. Minor emergency repairs, such as flat tires, will be performed on an immediate basis at the Township facility, (DPW garage) during normal business hours.

e. Salting Parking Lots at Schools. On an as needed basis, when requested by the BOE, the Township will salt the parking lots at Sharon Elementary School, Pond Road Middle School, and Robbinsville High School. See 3c for fees.

3. **Fees.** The Township shall charge the BOE for automotive services as follows:
 - a. Labor rate of \$63.67 per man hour
 - b. 10% over Township cost for all repair parts and sublet parts. No charge will be made for parts which are supplied by the BOE.
 - c. The BOE will be billed for salt usage at \$87.75 per ton, and \$63.67 per hour for Salt Truck w/ Driver. A typical salting event would require 3 tons of salt and one hour.
4. **Billing and Payment.** The Township shall provide the BOE with itemized monthly billings of all repair costs. Payment shall be due from the BOE within 30 (thirty) days of the date of billing.
5. **Liability.** The Township and the BOE shall be responsible for acts of their own negligence consistent with the provisions of the *New Jersey Tort Claims Act, N.S.J.A. 59:1-1 et seq.*, arising out of or related to performance of any activity under the terms of this Agreement.
6. Each party shall notify the other in writing sixty (60) days before expiration of this agreement if it desires to continue services and negotiate a new contract for the succeeding year.

IN WITNESS WHEREOF, parties of the Agreement have caused it to be signed by their proper officers and their corporate seals to be affixed as of the day and year set forth above.
