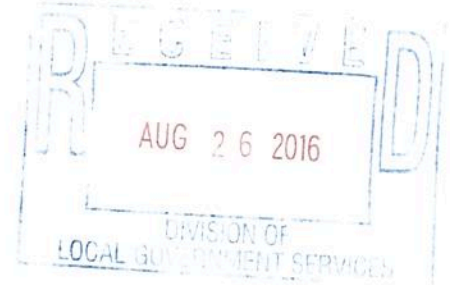

BRIEF DESCRIPTION OF SERVICE:

The Borough of Westville will be reconstructing Ryan Avenue with an NJDOT Local Aid Grant FY2015. The Borough will be extending the paving limits of Ryan Avenue into the Township of Deptford. The extension will be approximately 300 feet in length and terminate at the right of way line of NJSH No.47. This extension will facilitate a complete street. The estimated cost saving will be approximately \$20,000.00 by completing both Municipalities' portions of the roadway concurrently.

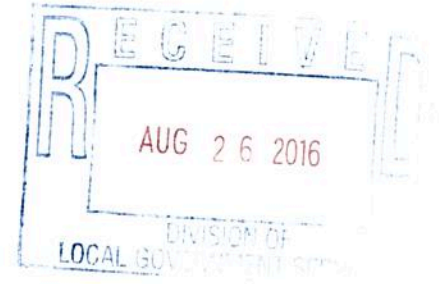

AUTHORIZING A SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF DEPTFORD FOR A ROAD IMPROVEMENT PROJECT ON RYAN AVENUE

WHEREAS, the Borough of Westville and the Township of Deptford share a municipal boundary line along a part of Ryan Avenue; and

WHEREAS, each of the municipalities have determined that road improvements to Ryan Avenue are necessary to preserve public safety and improve traffic flow along the said Ryan Avenue; and

WHEREAS, the Borough of Westville has received a Local Aid Grant from the New Jersey Department of Transportation to defray the anticipated costs of the improvements; and

WHEREAS, the Borough of Westville has agreed that the Borough's police department shall be responsible for any traffic control necessary for the above referenced road improvements; and

WHEREAS, the Borough of Westville agrees that any necessary permits from Gloucester County, the State of New Jersey, and any other entities which require permits shall be the sole responsibility of the Borough; and

WHEREAS, the Township of Deptford will be responsible for future maintenance of the portion of the roadway within the Township of Deptford's municipal limits; and

WHEREAS, the New Jersey Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq, authorizes municipalities to enter into Shared Service Agreements in order to reduce local expenses; and

WHEREAS, the Borough of Westville wishes to enter into a Shared Services Agreement with the Township of Deptford in order to undertake and complete the road improvements proposed if the costs of such improvements are approved for funding by the New Jersey Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council that the Mayor and Clerk are hereby authorized and directed to endorse the annexed Shared Services Agreement with the Township of Deptford;

BE IT FURTHER RESOLVED that, pursuant to N.J.S.A. 40A:65-4(3)(b), a certified true copy of this Resolution and the referenced Shared Services Agreement shall be filed with the New Jersey Department of Community Affairs, Division of Local Government Services, 101 South Broad Street, Trenton, New Jersey 08625 upon its adoption and that a certified true copy of this Resolution shall also be furnished to the Clerk of the Township of Deptford forthwith after its adoption;

BE IT FURTHER RESOLVED that the Shared Services Agreement referenced above shall take effect upon the adoption of a reciprocal resolution authorizing its execution by the Township of Deptford.


