**MUNICIPAL
SHARED SERVICES AGREEMENT**

THIS AGREEMENT, dated 30th day of March, 2016, by and between **TOWNSHIP OF GLOUCESTER**, a municipal corporation of the State of New Jersey, located at Chews Landing road, P.O. Box 8, Blackwood, New Jersey 08012 (hereinafter called "GLOUCESTER TOWNSHIP"), and Borough of Clementon, located at 101 Gibbsboro Road, Clementon, New Jersey 08021 (hereinafter called "BOROUGH OF CLEMENTON").

WITNESSETH

WHEREAS. The parties desire to enter into a Municipal Services Agreement authorizing Gloucester Township to provide Public Works services to refurbish three (3) ball fields and to repair and maintain their vehicle fleet to the Borough of Clementon, and

WHEREAS. The parties desire to enter into an agreement memorializing the terms and conditions of the agreement between GLOUCESTER TOWNSHIP and BOROUGH OF CLEMENTON.

NOW THEREFORE, for and inconsideration of the signing of this Agreement by the parties, and in further consideration of the terms and covenants of the within Agreement, and the mutual benefits derived by the parties hereto, the Parties do hereby agree as follows:

ARTICLE I
AGREEMENT

A. Gloucester Township will provide for the Public Works services necessary to refurbish three (3) ball fields to Borough of Clementon and to repair and maintain their vehicle fleet.

ARTICLE II
TERM

A. This Municipal Shared Services Agreement shall commence on March 31st 2016 and continue for a term until December 31st 2016. This service agreement will not automatically renew and this agreement shall expire at the end of the current term and shall become null and void of no further legal effect.

ARTICLE III
GENERAL CONDITIONS
AND TERMS

A. If any one or more of the terms and provisions of this agreement shall be determined invalid or unenforceable by a Court of Law, the remainder of the terms of provisions thereof shall not be affected thereby and shall continue to be enforceable in all respects.

B. This agreement shall be governed and construed in accordance with the laws of the State of New Jersey.


C. Borough of Clementon shall pay compensation to Gloucester Township in an amount set for the in schedule "A" attached, to be paid within 45 days following the Borough of Clementon's receipt of a purchase voucher from Gloucester Township.

D. Gloucester Township and Borough of Clementon may approve and adjust as necessary the provisions of this municipal shared service agreement.


E. This agreement may only be amended, modified or changed in a dated writing, executed by Gloucester Township and Borough of Clementon.



SCHEDULE "A"

1. Borough of Clementon shall schedule all services with Gloucester Township's Director of Public Works and are subject to the availability of staff.
2. The Township of Gloucester will bill the Borough of Clementon the applicable rate as listed below or as may be amended from time to time plus parts and materials for the refurbishment of three (3) ball fields and will include a 15% Township Administration charge which is applicable to the entire bill.
3. The Township of Gloucester will bill the Borough of Clementon the applicable rate as listed below or as may be amended from time to time plus parts and materials for the repair and maintenance of their vehicle fleet and will include a 15% Township Administration charge which is applicable to the entire bill.
