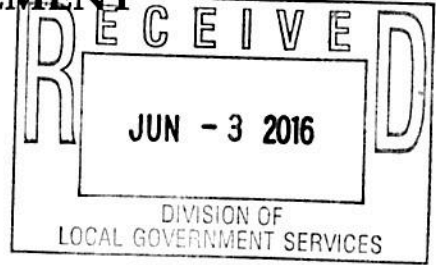

**INTERLOCAL AGREEMENT
BETWEEN
THE OLD BRIDGE BOARD OF EDUCATION
AND
THE TOWNSHIP OF OLD BRIDGE**

**TRANSPORTATION
FOR THE TOWNSHIP SUMMER 2016 RECREATION PROGRAM**

This agreement made and entered into this 31st day of July 2016 by and between the Old Bridge Board of Education (hereinafter referred to as the "Board" or the "Lead Agency") and the Township of Old Bridge (hereinafter referred to as the "Township").

WITNESSETH:

WHEREAS, the Board and the Township recognize the need to provide transportation for the township summer recreation program; and

WHEREAS, the Board and the Township wish to cooperate so that the transportation required can be provided in the most efficient and cost-effective manner; and

WHEREAS, it is the desire of the parties to enter into this Agreement for said purpose.


NOW, THEREFORE, IN CONSIDERATION of mutual covenant, terms and conditions hereinafter set forth, the sufficiency of which is hereby acknowledged, the parties hereto do hereby agree as follows:

1. The Board shall provide transportation for the summer recreation program for a time period not to extend beyond August 16th, to allow for required bus maintenance and inspection prior to the opening of school ;
2. The Township will make every effort to schedule trips no earlier than 9:30 AM to allow the Board to transport the Extended School Year Pre-School Disabled Students prior to picking up the township recreation program students. This will reduce the cost to the Board for contracted transportation services;
3. The Township will make every effort to coordinate and schedule its Recreation Program trips and Camp Robin Program trips to allow for efficient use of Board vehicles, to ensure that adequate equipment is available for backup in the event of accident or vehicle malfunction. Due to greater demands on Board vehicles to operate summer extended year programs for the district's disabled children, the Township will advise the Board no later than March 31st, prior to the summer program, the number of vehicles (buses, vans and wheelchair vans) requested to run the Township's summer program;


4. The Township will make every effort to limit any trips over a twenty (20) mile distance.
5. The Township will agree to offset the costs for providing transportation for the summer recreation program for the summer of 2016 in the amount of **\$17,500 (\$8,750 payable on July 1st and \$8,750 on August 16th)**.
6. **In the event a wheelchair van is needed by the Township, the Township will reimburse the Board for the cost of that rental, estimated to be @ \$200 per day.**
7. The Board and the Township will meet on an annual basis to review the summer recreation program needs and determine the fee to offset costs to the Board.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be signed and executed by their authorized corporate officer and their respective seals to be hereto affixed the day and year above written.


