**AGREEMENT BETWEEN
THE BOROUGH OF MEDFORD LAKES AND
THE TOWNSHIP OF MEDFORD FOR
CERTIFIED RECYCLING PROFESSIONAL SERVICES**

THIS AGREEMENT by and between the **BOROUGH OF MEDFORD LAKES** (municipality), a municipal body politic having its offices at **1 CABIN CIRCLE, NEW JERSEY, 08055**, and the **TOWNSHIP OF MEDFORD**, a municipal body politic having its offices located at **17 NORTH MAIN STREET, MEDFORD, NEW JERSEY 08055** is dated this **23rd** day of **April, 2015**.

WHEREAS, the **BOROUGH OF MEDFORD LAKES**, by ordinance, has duly enacted a recycling plan for all recyclable materials as designated by the Burlington County Solid Waste Management Plan and amendments thereto and:

WHEREAS, the **BOROUGH OF MEDFORD LAKES** is desirous of retaining Certified Recycling Professional (hereinafter "CRP") services of the **TOWNSHIP OF MEDFORD** for said recycling program; and

WHEREAS, the award of this agreement to the **TOWNSHIP OF MEDFORD** pursuant to N.J.S.A. Section 13:1E-99.14 is an exception to the bidding requirements as set forth in the "Local Public Contracts Law" pursuant to N.J.S.A. Section 40A:11-5(2), and the Board of Chosen Freeholders for Burlington County.

NOW, THEREFORE, in consideration of the terms, conditions, mutual benefits and covenants hereinafter set forth, the **BOROUGH OF MEDFORD LAKES** and the **TOWNSHIP OF MEDFORD** make this agreement.

1. The **BOROUGH OF MEDFORD LAKES** shall retain the services of the **TOWNSHIP OF MEDFORD** for a CRP that will be responsible for coordinating municipal recycling requirements as provided in the Burlington

County Solid Waste Management Plan, and with the State New Jersey Department of Environmental Protection (NJDEP) for mandatory annual municipal recycling tonnage report documentation.


2. The **BOROUGH OF MEDFORD LAKES** shall provide the **TOWNSHIP OF MEDFORD** with any changes in definition of the CRP's position.
3. The **BOROUGH OF MEDFORD LAKES and/or TOWNSHIP OF MEDFORD** reserves the right to terminate the agreement or reasonably amend the specifications of this Agreement by giving thirty- (30) day written notification to the **TOWNSHIP OF MEDFORD and/or BOROUGH OF MEDFORD LAKES** of any changes thereto.
4. The **BOROUGH OF MEDFORD LAKES** shall pay a fee of \$100.00 annually to the **TOWNSHIP OF MEDFORD** for the CRP's service.
5. The **BOROUGH OF MEDFORD LAKES** will pay all invoices within thirty (30) days.
6. This agreement is the entire agreement between the **BOROUGH OF MEDFORD LAKES** and the **TOWNSHIP OF MEDFORD** and supersedes all previous agreements and discussions regarding CRP service. Any amendments hereto must be in writing and must be duly executed by the **BOROUGH OF MEDFORD LAKES** and the **TOWNSHIP OF MEDFORD** to become effective.
7. This Agreement will be entirely performed within the State of New Jersey and it shall be construed in accordance with the laws thereof.
8. If any provision of this Agreement is determined by a court of competent jurisdiction to be illegal, void, ultravires, or unconstitutional, the remainder of

this Agreement shall continue in full force and effect.


9. Term: This agreement shall take effect upon the lawful execution of the agreement by both parties and shall expire April 22, 2016.




