**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING AN INTERLOCAL AGREEMENT WITH  
THE COUNTY OF MIDDLESEX  
FOR ROAD LINE STRIPING**

**WHEREAS**, pursuant to Local Public Contracts Law N.J.S.A. 40A:11-5(2) et seq., municipalities within the State of New Jersey are permitted to enter into agreements with other local units of government, including County agencies, for the provision of services; and


**WHEREAS**, the Township of North Brunswick (TOWNSHIP) is desirous of the County of Middlesex (COUNTY) to provide road line striping on an as-need basis for municipal roads; and


**WHEREAS**, the TOWNSHIP shall compensate the COUNTY for equipment, wages and material used to line stripe municipal roads.


**NOW, THEREFORE, BE IT RESOLVED**, on this 19<sup>th</sup> of September 2016, the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, hereby authorizes road line striping to be performed by the COUNTY on an as-needed basis under the following terms:

1. The COUNTY shall have the right to enter upon the TOWNSHIP'S right-of-way for the purpose of performing the installation of road line striping.
2. The COUNTY, at the TOWNSHIP'S Expense, shall perform the work requested on an as-need basis.
3. It is understood and agreed that the final total costs for line striping will be based on costs incurred.
4. Compensation to the COUNTY shall include, without limitation, direct labor, fringe benefits, retroactive wage adjustments when paid, any other payments the COUNTY is obligated to pay under union agreements, materials, rental of equipment and payments to others incurred in performance of work.
5. The TOWNSHIP shall be responsible for providing notification of the work to the property owners along the roadway and to business and emergency services as determined appropriate by the TOWNSHIP.
6. This agreement is the entire agreement between the parties and no alterations, changes or additions herein shall be made except in writing and approved by the parties thereto.
7. The aforesaid services which shall commence retroactive to September 1, 2016 and shall terminate on August 31, 2021.

**BE IT FURTHER RESOLVED**, the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, hereby authorizes the Mayor to execute and the Clerk to witness an agreement with the County of Middlesex to provide road line striping on an as-need basis for municipal roads.


