RESOLUTION AUTHORIZING THE ENTRY INTO AN INTERLOCAL SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF MONTVILLE AND THE TOWNSHIP OF WEST CALDWELL FOR VACTOR TRUCK EQUIPMENT AND OPERATOR

WHEREAS, pursuant to N.J.S.A. 40A:65-1, the Township of Montville may, by Resolution, enter into an Interlocal Services Agreement with another local government entity; and

WHEREAS, the Township of Montville and the Township of West Caldwell have agreed to enter into an Interlocal Services Agreement to provide for the use and operation of a Vactor Truck for a term of five years.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Montville, in the County of Morris, and State of New Jersey, that the appropriate municipal officials are hereby authorized to enter into an Agreement between the Township of Montville and the Township of West Caldwell for the use and operation of a Vactor Truck, for a term of five years in an amount to be paid to the Township of Montville of One Thousand One Hundred Fifty (\$1,150.00) Dollars per day as set forth in the Agreement attached hereto.

INTERLOCAL SERVICE AGREEMENT

THIS AGREEMENT, made this 14th day of January, 2014, by and between the Township of West Caldwell, having an address at 30 Clinton Road, West Caldwell, New Jersey 07006 (hereinafter "West Caldwell") and the Township of Montville, having an address of 195 Changebridge Road, Montville, New Jersey 07045 (hereinafter "Montville");

WHEREAS, Montville is presently operating a Vactor Truck (Jet-Vacuum) and West Caldwell desires to use Montville's Vactor Truck with an operator from Montville to accommodate the needs of the West Caldwell; and

WHEREAS, Montville is agreeable to allowing West Caldwell to utilize its Vactor Truck and operator under certain terms and conditions; and

WHEREAS, the governing bodies of the two municipalities have adopted resolutions pursuant to N.J.S.A. 40A:65-1 et seq., the Interlocal Services Act, authorizing the adoption of this agreement.

NOW, THEREFORE, the parties agree as follows:

1. West Caldwell shall pay Montville an amount of One Thousand One Hundred Fifty Dollars (\$1,150.00) per day for seven (7) hours of use and operation which shall be paid within thirty (30) days of the service being provided. The rate shall increase five percent (5%) annually beginning on January 1, 2015.
2. This agreement shall be for a period of five (5) years and can be terminated by either of the parties giving thirty (30) days notice to the other and shall continue in full force and effect until either of the parties provide this notice.
3. West Caldwell agrees to provide labor assistance on an as needed basis to the Vactor Truck operator.
4. The operator shall be an employee of Montville and not an employee of West Caldwell. Each municipality shall properly supervise and insure its employees at all times.
5. Each municipality agrees to indemnify and hold harmless the other harmless for any liability occasioned by the use of their respect equipment and employees.

IN WITNESS WHEREOF, the parties hereto have caused this agreement to be signed by their respective officers as of the day and year first above written.


