**SHARED SERVICES AGREEMENT AMENDMENT BETWEEN THE
TOWNSHIP OF MOUNT OLIVE AND THE TOWNSHIP OF WASHINGTON,
COUNTY OF MORRIS
FOR THE TOWNSHIP OF MOUNT OLIVE TO PROVIDE
ANIMAL CONTROL SERVICES TO AND FOR THE TOWNSHIP OF
WASHINGTON**

THIS SHARED SERVICES AGREEMENT (the "Agreement") is made on the 13 day of July, 2016 by and between the Township of Washington, County of Morris, a municipal corporation of the State of New Jersey with offices located at 43 Schooley's Mountain Road, Long Valley, New Jersey, hereinafter referred to as "Washington," and the Township of Mount Olive, County of Morris, a municipal corporation of the State of New Jersey, with offices located at 204 Flanders-Drakestown Road, Budd Lake, New Jersey, hereinafter referred to as "Mount Olive."

WHEREAS, Mount Olive and Washington have previously entered into a contract dated December 21, 2015 pursuant to N.J.S.A. 40A-65-1, et seq. (the "Uniform Shared Services and Consolidation Act") to enable Mount Olive to provide animal control services to Washington; and

WHEREAS, it is deemed in the best of interest of the residents of Mount Olive and Washington to amend the contract to enable Mount Olive to provide animal cruelty investigator services to Washington; and

NOW, THEREFORE, Mount Olive and Washington in consideration of the mutual promises and covenants herein set forth, agree as follows:

1. A new paragraph 8 is hereby added to read as follow:

Animal Cruelty Investigator Scope of Services

Mount Olive agrees to provide a licensed and certified Animal Cruelty Investigator, an approved vehicle for the transportation of animals (with heat and air conditioning) and proper equipment to render animal cruelty investigator services to Washington under the sole and exclusive direction of Mount Olive. Requests by residents of Washington for animal cruelty investigator services shall be directed to Washington and services will be provided only upon request of a duly authorized Washington official or Washington Police Officer.

2. A new paragraph 9 is hereby added to read as follow:


Animal Cruelty Investigator Consideration.

Washington agrees to pay Mount Olive the sum of \$75 per hour for animal cruelty investigator services.

RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE AUTHORIZING THE EXECUTION OF AN AMENDMENT TO THE SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF MOUNT OLIVE AND THE TOWNSHIP OF WASHINGTON FOR THE PROVISION OF ANIMAL CONTROL SERVICES

WHEREAS, currently the Township of Mount Olive ("Mount Olive") and the Township of Washington ("Washington") have entered into a shared services agreement pursuant to which Mount Olive provides animal control services to Washington; and

WHEREAS, a need has developed for Mount Olive to provide animal cruelty investigation services to Washington in addition to the already contracted for services; and

WHEREAS, it is in the best interests of Mount Olive to perform said services as part of the animal control services already being provided to Washington; and

WHEREAS, the Mayor and Township Council have reviewed, are familiar with and have agreed to the terms and conditions of the amendment to the shared services agreement between Mount Olive and Washington for the provision of animal control services, including animal cruelty investigator services.


NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Council of the Township of Mount Olive, in the County of Morris, that the Mayor is hereby authorized and directed to execute the attached amendment to the shared services agreement between Mount Olive and Washington for the provision of animal control services, including animal cruelty investigator services.
