#### SHARED SERVICES AGREEMENT BETWEEN THE BOROUGH OF LITTLE FERRY

THIS AGREEMENT, made this 12 day of August, 2014, by and between: 12 BOARD

THE BOROUGH OF LITTLE FERRY, a body politic and corporate of the State of New Jersey, through the Mayor and Council, hereinafter referred to as the "Little Ferry";

and

THE VILLAGE OF RIDGEFIELD PARK, a body politic and corporate of the State of New Jersey, hereinafter referred to as "Ridgefield Park."

#### WITNESSETH:

WHEREAS, each summer the Borough of Little Ferry sponsors the Little Ferry/Ridgefield Park Junior Police Academy; and

WHEREAS, each summer the Village of Ridgefield Park sponsors the Little Ferry/Ridgefield Park Junior Police Academy; and

WHEREAS, it is in the best interest of each municipality to jointly share in the sponsorship of the Little Ferry/Ridgefield Park Junior Police Academy; and

WHEREAS, the parties desire to enter into this Shared Services Agreement;

## NOW, THEREFORE, BE IT RESOLVED THAT THE PARTIES AGREE AS FOLLOWS:

- 1. The Borough of Little Ferry and the Village of Ridgefield hereby enter into this Agreement wherein they agree to jointly sponsor the Little Ferry/Ridgefield Park Junior Police Academy each summer for the next five (5) years; and
- 2. This Agreement shall be in effect from June 1, 2014 to June 30, 2019.

This Agreement shall become effective upon the passing by both parties at their public meetings.
