RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING A SHARED SERVICES AGREEMENT WITH
MIDDLESEX COUNTY PUBLIC HEALTH DEPARTMENT
FOR HEALTH AND ENVIRONMENTAL SERVICES

WHEREAS, pursuant to the Shared Services Act, N.J.S.A. 40A:65-1 et seq., municipalities within the State of New Jersey are permitted to enter into agreements with other local units of government, including County agencies, for the provision of services; and

WHEREAS, the County of Middlesex Public Health Department offers health and environmental services of a technical and professional nature to municipalities operating under a Shared Services Agreement; and

WHEREAS, North Brunswick Township has previously used the County of Middlesex Public Health Department to carry out various public activities and is desirous of continuing services provided; and

WHEREAS, the current Shared Services Agreement will expire on December 31, 2015 and the County of Middlesex Public Health Department has offered to continue such service for a two (2) year term, commencing January 1, 2016 and continuing until December 31, 2017; and

WHEREAS, the County of Middlesex Public Health Department has offered a rate of \$91,973.18 for 2016 and the rate of \$93,812.64 for 2017; and

WHEREAS, the Chief Financial Officer certified that Forty-Five Thousand Nine Hundred Dollars and Eighty-Six Dollars and Fifty-nine Cents (\$45,986.59) is available for this purpose in the FY 2016 under account number 6-01-28-330-000-139, and the balance will be available subject to appropriation in the FY2017 and FY2018.


NOW THEREFORE BE IT RESOLVED, on the 4th day of April 2016, the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, hereby authorizes:

1. The Mayor or Business Administrator to execute a Shared Service Agreement with the County of Middlesex Public Health Department to provide health and environmental services at a rate of \$91,973.18 for 2016 and the rate of \$93,812.64 for 2017;
2. Prior to execution of Shared Services agreement, the Township Attorney is authorized to review the agreement as to form: and
3. Said agreement shall commence January 1, 2016 and continue until December 31, 2017 unless either party exercises its right to terminate the agreement in accordance with the agreement.


I, Kala Sriranganathan Chief Financial Officer, certify that \$45,986.59 is available for this purpose in the FY 2016 Budget in Account # 6-01-28-330-000-139, and the balance will be available subject to appropriation in the FY 2017 and FY 2018 budgets.






