BASIS FOR AN AGREEMENT FOR THE RESALE OF ROCK SALT AS PART OF A COMMUNITY RESALE SYSTEM

AN AGREEMENT for the resale of Rock Salt made of this 20th day of December 2017 (effective January 1, 2018) by and between The Township of Millstone Board of Education and the Township of Millstone entered into pursuant to the Commodity Resale Provisions of the Cooperative Purchasing Rules (N.J.A.C. 5:34-7.1 et seq.).

WHEREAS, The Township of Millstone owns and operates a Rock Salt Shed for its own needs; and

WHEREAS, The Township of Millstone Board of Education is desirous of making use of the Rock Salt purchased by The Township of Millstone located at 899 Perrineville Road.

NOW THEREFORE, in consideration for the promises and of the mutual covenants herein contained, the parties hereto agree as follows:

1. SUPPLY OF ROCK SALT

The Township of Millstone will provide an estimated 20 tons of Rock Salt for use by the Township of Millstone Board of Education. In the event that The Township of Millstone Board of Education Rock Salt consumption increases over the above stated tons, The Township of Millstone shall bill for the actual amount of tonnage consumed by The Township of Millstone Board of Education.

2. ROCK SALT RATE

The rate that The Township of Millstone Board of Education shall pay for the Rock Salt pursuant to the Agreement shall be the base Rock Salt rate plus an Administrative fee. It shall be as follows:

The Township of Millstone Board of Education Rock Salt rate shall be a combination of:

- (a) The contract cost which the Township of Millstone pays for Rock Salt; and
- (b) An administrative service charge of 15% on the amount of Rock Salt actually supplied.

3. PAYMENT OBLIGATION

A monthly invoice for the previous month's usage shall be forwarded from the Township of Millstone to The Township of Millstone Board of Education on or before the 15th of each month. Payment shall be made within 30 days of the receipt of invoice from The Township of Millstone.

4. SALT DISPENSING

All Rock Salt to be supplied by The Township of Millstone to The Township of Millstone Board of Education shall be dispensed by tonnage at the Salt Shed located at 899 Perrineville Road.

5. HOURS OF SERVICE

Unless notified in writing, the supply of Rock Salt is available between the hours of 7:30am and 3:30pm each working day.

6. EMERGENCIES

In the event of an emergency, The Township of Millstone will use its best efforts to provide all Rock Salt that The Township of Millstone Board of Education requires.

7. EXCUSED PERFORMANCE

The Township of Millstone agrees to use its best efforts to provide a continuous and regular uninterrupted supply of Rock Salt, subject to the terms of this Agreement.

8. INDEMNIFICATION

The Township of Millstone Board of Education shall completely indemnify, protect and hold harmless The Township of Millstone from any costs, expenses, liability, losses, claims, suits and proceeding of any nature whatsoever brought against the Township of Millstone as an additional insured on its liability policy with a minimum of One Million Dollars. The Township of Millstone Board of Education shall provide evidence of same by providing The Township of Millstone with a Certificate of Insurance within 14 days after this Agreement goes into effect. Failure of The Township of Millstone Board of Education to provide such a Certificate of Insurance shall be cause for termination of this Agreement.

9. TERMINATION

This Agreement shall be in effect from January 1, 2018 through December 31, 2018 upon approval by the governing bodies of The Township of Millstone and The Township of Millstone Board of Education. Either party may terminate this Agreement with 30 days advance notice by certified mail, to the official address of the other party.

10. GOVERNING LAW

This Agreement shall be governed by and interpreted in accordance with the laws of the State of New Jersey.

RESOLUTION AUTHORIZING THE TOWNSHIP OF MILLSTONE TO ESTABLISH A COMMODITY RESALE AGREEMENT WITH THE MILLSTONE TOWNSHIP BOARD OF EDUCATION

C/Grbelja offered the following Resolution and moved its adoption, which was second by M/Kuczinski:

WHEREAS, *N.J.A.C.* 5:34-7.15 authorizes contracting units to establish a Commodity Resale System; and

WHEREAS, the Township of Millstone, County of Monmouth, State of New Jersey is desirous of establishing a Commodity Resale System for the resale of Rock Salt; and

WHEREAS, the Township of Millstone, has agreed to serve as the Lead Agency for a Commodity Resale System with The Millstone Township Board of Education.

NOW, THEREFORE, BE IT RESOLVED on the 20th day of December 2017 (with an effective date of January 1, 2018) by the Governing Body of the Township of Millstone, County of Monmouth, State of New Jersey, as follows:

- The Governing Body hereby authorizes the creation of a Commodity Resale System to be known as the Township of Millstone/Millstone Township Board of Education Rock Salt Resale, with the Township of Millstone serving as the Lead Agency.
- The Mayor and Township Clerk are hereby authorized to enter into a contract with the Millstone Township Board of Education for the sale of Rock Salt.
- A single certified copy of this Resolution, along with a copy of the Purchase Agreement, and a copy of the Request for Registration or Modification of a Commodity Resale System Form shall be forwarded to the Director of the Division of Local Government Services within the State Department of Community Affairs.

This resolution shall take effect immediately upon passage.
