RESOLUTION AUTHORIZING EXECUTION OF INTERLOCAL/SHARED SERVICES CONTRACT WITH THE TOWNSHIP OF BLOOMFIELD BOARD OF HEALTH FOR LOCAL PUBLIC HEALTH SERVICES

WHEREAS, the Borough of Lincoln Park has certain statutory obligations to provide certain minimum health services and/or enforcing environmental health standards pursuant to N.J.S.A. 26:3A2-1 *et seq.* and N.J.A.C. 8:52 *et seq.*; and,

WHEREAS, the current Agreement with the Township of Bloomfield for health services and enforcement of environmental health standards is set to expire on December 31, 2016; and,

WHEREAS, the Township of Bloomfield Board of Health has offered to provide the Borough of Lincoln Park with the services of a Registered Environmental Health Specialist ("REHS") and a Certified Health Education Specialist ("CHES") pursuant to N.J.S.A.26:3A2-1, *et seq.* and N.J.A.C. 8:52 *et seq.* for an additional five years commencing January 1, 2017; and,

WHEREAS, the annual cost of said services shall be as follows:

2017 - \$17,856
2018 - \$18,035
2019 - \$18,306
2020 - \$18,672
2021 - \$18,905

and,

WHEREAS, the Borough of Lincoln Park desires to utilize said services.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Lincoln Park, County of Morris, State of New Jersey, as follows:

1. The execution of an InterLocal/Shared Services Agreement for the furnishing of the services of a Registered Environmental Health Specialist ("REHS") and a Certified Health Education Specialist ("CHES") pursuant to N.J.S.A.26:3A2-1, *et seq.* and N.J.A.C. 8:52 *et seq.* is hereby approved pursuant to the provisions of the Interlocal Services Act, N.J.S.A. 40:8A-1 *et seq.*; and,


2. The annual cost of said services shall be as follows:

2021 - \$18,905


3. A copy of said Agreement is on file in the office of the Borough Clerk and may be viewed during normal business hours; and,


5. A copy of the fully executed Agreement shall be forwarded to the Morris County Joint Insurance Fund.
