**WHEREAS**, on April 12, 2010 the Township of Upper entered into a Shared Services Agreement with the City of Corbin City to provide municipal court services; and


**WHEREAS**, pursuant to amendments to the Agreement the parties extended the term of the Agreement which now ends on May 5, 2016; and

**WHEREAS**, both parties desire to amend the term of said Shared Services Agreement for an additional three (3) years; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.
2. The Township Committee hereby authorizes the Mayor and Township Clerk to sign an Amendment to the Shared Services Agreement with the City of Corbin City to extend the term of said agreement for an additional three years, expiring on May 5, 2019.
3. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.



**NOW, THEREFORE, BE IT RESOLVED**, by the Common Council of the City of Corbin City, County of Atlantic and State of New Jersey, that paragraph 6 of the original Shared Services Agreement be replaced in its entirety with the following:

6. This agreement shall commence on May 6, 2016, and shall continue for a term of 3 years, ending on May 5, 2019. Except in the case of a material breach, this agreement may not be terminated by either party prior to May 5, 2019.



**AMENDMENT TO SHARED SERVICES AGREEMENT FOR  
MUNICIPAL COURT SERVICES BETWEEN  
TOWNSHIP OF UPPER AND CITY OF CORBIN CITY**

**WHEREAS**, the Township of Upper and the City of Corbin City have entered into a Shared Services Agreement dated April 12, 2010 for municipal court services pursuant to Upper Township Resolution No. 085-2010; and

**WHEREAS**, the parties have agreed to amend the existing Shared Services Agreement pursuant to the terms set forth herein.

**NOW, THEREFORE, IT IS AGREED AS FOLLOWS:**

1. Paragraph 6 of the original Agreement is replaced in its entirety with the following:


