AGREEMENT

This agreement, made this 1st day of January, 2017 between Board of Health and the Township Committee of the Township of Freehold, a municipal corporation of the State of New Jersey, hereinafter referred to as "Provider,"


And the Borough Council of Borough of Allentown, a municipal corporation of the State of New Jersey, hereinafter referred to as "Recipient."

Whereas, the parties desire to contract for the furnishing of a community emergency notification system;


Now, therefore, in consideration of the terms and conditions hereinafter set forth, the parties agree as follows:

1. The provider will oversee and manage a contract for an emergency notification system and act as liaison for the Borough of Allentown with the contract service provider.
2. The provider will provide administrative access to designated employee and/or Borough officials to the emergency notification platform, as requested by the Borough Council.
3. The provider shall provide the services specified from January 1, 2017 through December 31, 2017 at an annual cost of \$577.00. Invoices shall be billed in January and the procedure for payments (see N.J.S.A. 40A65-1 et seq.) is to be on township voucher.
4. Either recipient or provider may withdraw from this contract by adoption of a resolution. A certified copy of such a resolution shall be submitted to the provider or recipient at least six (6) months prior to the date of intended withdrawal. Unless either party initiates a six-month withdrawal resolution, this contract will be automatically renewed. The withdrawing party will submit any notification of withdrawal to the New Jersey State Commissioner of Health at least six (6) months prior to the withdrawal date.
