RESOLUTION AUTHORIZING AND APPROVING SHARED SERVICES AGREEMENT BETWEEN MONROE TOWNSHIP "RECIPIENT" AND OLD BRIDGE TOWNSHIP "PROVIDER" FOR ANIMAL SHELTER SERVICES

WHEREAS, the Township of Monroe (Recipient) desires to contract with the Township of Old Bridge (Provider) for purposes of providing the Township of Monroe with access to the Old Bridge Township Shelter and Services provided therein; and.

WHEREAS, the Township of Old Bridge has agreed to provide the Township of Monroe with this service at the rate of \$12,000.00 per year (\$1,000.00 per month) as an administrative fee and \$10.00 per day Daily Boarding Fee, \$12.00 Daily Boarding Fee (Quarantine), \$45.00 per day Daily Boarding Fee (vicious/potentially dangerous dog) and transportation to Monroe's veterinarian at \$25.00 per occurrence; and

WHEREAS, the Township of Monroe is authorized to enter into this Shared Services Agreement with the Township of Old Bridge pursuant to the provisions of Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq; and

WHEREAS, the Township of Old Bridge has the capabilities to efficiently and economically provide the services required by the Township of Monroe; and


WHEREAS, the agreement is in the best interest of the parties hereto.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Old Bridge, County of Middlesex and State of New Jersey that the Shared Services Agreement between the Township of Monroe (Recipient) and the Township of Old Bridge (Provider) for the Animal Sheltering Services is authorized and accepted and the Mayor and Clerk are hereby authorized to execute said agreement on behalf of the Township of Old Bridge with the Township of Monroe for
