



**RESOLUTION FOR MEMBER PARTICIPATION IN A  
COOPERATIVE PRICING SYSTEM**

**WHEREAS**, N.J.S.A. 40A:11-10 authorizes contracting units to establish a Cooperative Pricing System and to enter in Cooperative Pricing Agreements for its administration; and

**WHEREAS**, the Township of Voorhees, hereinafter referred to as the "Lead Agency" has offered voluntary participation in a Cooperative Pricing System for the goods and services; and

**WHEREAS**, on October 8, 2015, the governing body of the Borough of Somerdale, County of Camden, State of New Jersey duly agreed to participate in a Cooperative Pricing System by Resolution 2015-126 for the purchase of goods and services;

**WHEREAS**, such goods and services are in the form of a contract to provide Miscellaneous Road and Drainage work from DiMeglio Construction;

**NOW, THEREFORE BE IT RESOLVED** this resolution shall be known and may be cited as the Cooperative Pricing Resolution of Voorhees Township, and

**BE IT FURTHER RESOLVED** pursuant to the provisions of N.J.S.A. 40A:11-10, the mayor is hereby authorized to enter into a Cooperative Pricing Agreement with the Borough of Somerdale, and

**BE IT FURTHER RESOLVED** the Borough of Somerdale shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

**BE IT FURTHER RESOLVED** this resolution shall take effect immediately upon passage.


