**AGREEMENT TO EXTEND THE RECREATION SHARED SERVICES
AGREEMENT BETWEEN THE TOWNSHIP OF WEST CALDWELL
AND
THE BOROUGH OF CALDWELL**

THIS AGREEMENT is made on the date or dates set forth at the signature lines below, by and between:

The **Township of West Caldwell**, a Municipal Corporation and body politic organized and existing by virtue of the laws of the State of New Jersey, in the County of Essex and the State of New Jersey with offices at 30 Clinton Road, West Caldwell, New Jersey 07006 (referred to as "West Caldwell"); and

The **Borough of Caldwell**, a Municipal Corporation and body politic organized and existing by virtue of and in accordance with the laws of the State of New Jersey, in the County of Essex and State of New Jersey with offices at One Provost Square, Caldwell, New Jersey 07006 (referred to as "Caldwell");

Whereas, N.J.S.A. 40A:65-1 et seq., the Uniform Shared Services and Consolidation Act, authorizes municipalities to enter into Shared Services Agreements; and

Whereas, West Caldwell administers a recreation program (the "Recreation Program") for the benefit of the parties pursuant to the terms of a Shared Services Agreement dated March 11, 2011, which agreement expires on December 31, 2020; and

Whereas the parties wish to extend the Shared Services Agreement for an additional five (5) year term so as to allow West Caldwell to continue to administer the Recreation Program until the expiration of the EVS Shared Services Agreement.


Now Therefore It is Agreed:

- 1. Extension of Recreation Shared Services Agreement.** The Recreation Shared Services Agreement between Caldwell and West Caldwell executed on March 11, 2011 and heretofore scheduled to expire on December 31, 2020, is hereby extended so that the Agreement will terminate simultaneously with the EVS Improvement Agreement on December 31, 2025.


