**MUNICIPAL
SHARED SERVICES AGREEMENT**

THIS AGREEMENT, dated 12 day of December, 2017, by and between **TOWNSHIP OF GLOUCESTER**, a municipal corporation of the State of New Jersey, located at Chews Landing road, P.O. Box 8, Blackwood, New Jersey 08012 (hereinafter called "GLOUCESTER TOWNSHIP"), and Township of Winslow, located at 125 South Route 73, Braddock, New Jersey 08037-9422 (hereinafter called "TOWNSHIP OF WINSLOW").

WITNESSETH

WHEREAS. The parties desire to enter into a Municipal Services Agreement authorizing Gloucester Township to provide "Brine Solution to the Township of Winslow, and

WHEREAS. The parties desire to enter into an agreement memorializing the terms and conditions of the agreement between GLOUCESTER TOWNSHIP and TOWNSHIP OF WINSLOW.

NOW THEREFORE, for and inconsideration of the signing of this Agreement by the parties, and in further consideration of the terms and covenants of the within Agreement, and the mutual benefits derived by the parties hereto, the Parties do hereby agree as follows:

ARTICLE I
AGREEMENT

A. Gloucester Township will provide for the sale of "Brine Solution" to Township of Winslow. The "Brine Solution" will be available for purchase at cost and availability as reflected on Schedule "A" at the Township of Gloucester, Department of Public Works Garage during the term of this agreement. The "Brine Solution" pick up dates shall be scheduled by the respective Municipal Public Works Department Director.

ARTICLE II
TERM

A. This Municipal Shared Services Agreement shall commence on January 1st 2018 and continue for a term until December 31st 2018. The service agreement shall automatically renew for successive twelve month periods thereafter, unless sixty (60) days written notice by either party to the other of the intent to terminate said agreement. Upon receipt of such notice to terminate, this agreement shall expire at the end of the then current term and shall become null and void of no further legal effect.

ARTICLE III
GENERAL CONDITIONS
AND TERMS

A. If any one or more of the terms and provisions of this agreement shall be determined invalid or unenforceable by a Court of Law, the remainder of the terms of provisions thereof shall not be affected thereby and shall continue to be enforceable in all respects.

B. This agreement shall be governed and construed in accordance with the laws of the State of New Jersey.


C. Township of Winslow shall pay compensation to Gloucester Township in an amount set for the in Schedule "A" attached, to be paid within 45 days following the Township of Winslow's receipt of a purchase voucher from Gloucester Township.

D. Gloucester Township and Township of Winslow may annually approve and adjust as necessary the provisions of this municipal shared service agreement.


E. This agreement may only be amended, modified or changed in a dated writing, executed by Gloucester Township and Township of Winslow.

WHEREAS, a Certificate of Availability of Funds will be obtained from the Chief Financial Officer at the time of actual purchase are made in accordance with this agreement.


