

RESOLUTION

EXERCISING OPTION TO EXTEND FOR ONE-YEAR SHARED SERVICES AGREEMENT WITH THE BOROUGH OF WILDWOOD CREST FOR MUNICIPAL CONSTRUCTION OFFICIAL

WHEREAS, by Resolution #468-15, adopted August 5, 2015, the Board of Commissioners of the Borough of Wildwood Crest authorized the Mayor and Borough Clerk to enter into a Shared Services Agreement with the City of North Wildwood for a Municipal Construction Official; and

WHEREAS, the aforementioned Agreement will expire on December 31, 2016; and

WHEREAS, the aforementioned Agreement provides for extensions from year-to-year by mutual agreement and resolution of both municipalities, with the last renewal to expire no later than December 31, 2021; and

WHEREAS, the Board of Commissioners now deems it to be in the best interests of the Borough of Wildwood Crest to exercise another one-year extension to expire on December 31, 2018.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Borough of Wildwood Crest, in the County of Cape May and State of New Jersey, as follows:


- 1) All of the statements of the preamble are repeated and incorporated herein by this reference thereto as though the same were set forth at length.

EXERCISING OPTION TO EXTEND FOR ONE-YEAR SHARED SERVICES AGREEMENT WITH THE BOROUGH OF WILDWOOD CREST FOR MUNICIPAL CONSTRUCTION OFFICIAL

WHEREAS, by Resolution #161-15, adopted August 4, 2015, the City Council of the City of North Wildwood authorized the Mayor and City Clerk to enter into a Shared Services Agreement with the Borough of Wildwood Crest for a Municipal Construction Official; and

WHEREAS, the aforementioned Agreement expired on December 31, 2016; and

WHEREAS, the aforementioned Agreement provides for extensions from year-to-year by mutual agreement and resolution of both municipalities, with the last renewal to expire no later than December 31, 2021; and

WHEREAS, by Resolution #205-16, adopted October 18, 2016, Council exercised the first of the available one-year options, extending the agreement until December 31, 2017; and

WHEREAS, Council now deems it to be in the best interests of the City of North Wildwood to exercise a one-year extension to expire on December 31, 2018.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of North Wildwood, in the County of Cape May and State of New Jersey, as follows:

- 1) All of the statements of the preamble are repeated and incorporated herein by this reference thereto as though the same were set forth at length.
- 2) By this Resolution, the City of North Wildwood hereby does exercise a one-year extension in the aforementioned Agreement.
- 4) The Mayor and City Clerk be and they are hereby authorized to execute any and all documents pertaining to said extension for a Municipal Construction Official for a term beginning on January 1, 2018 and terminating December 31, 2018.
- 5) The one-year extension authorized by this Resolution is contingent upon the governing body of the Borough of Wildwood Crest adopting a corresponding resolution in accordance with law at a public meeting held in compliance with the Open Public Meetings Act and the Uniform Shared Services and Consolidation Act.
