A motion was made by Franco Mazzei seconded by Richard Jasterzbski that the following resolution be adopted:

**AUTHORIZING A SHARED SERVICES AGREEMENT WITH THE CITY OF  
PATERSON DEPARTMENT OF HEALTH AND HUMAN SERVICES, DIVISION  
OF HEALTH FOR THE FURNISHING OF TUBERCULOSIS CONTROL SERVICES**

**WHEREAS**, the Township of Wayne is in need of tuberculosis control services for its residents; and

**WHEREAS**, the City of Paterson Department of Health and Human Services, Division of Health is in receipt of grant funding from the New Jersey Department of Health to provide Tuberculosis Control Services of a technical and professional nature pursuant to N.J.S.A. 26:3A2-1 et seq. and N.J.A.C. 8:57-5 to the residents of the County of Passaic; and

**WHEREAS**, the Uniform Shared Services and Consolidation Act (the "Act"), N.J.S.A. 40A:65-1 to -35, provides that any local unit may, by adoption of a resolution of its governing body, enter into an agreement with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction; and

**WHEREAS**, N.J.S.A. 40A:65-7a(4) provides that the duration of any agreement under the Act shall be ten (10) years unless otherwise agreed upon by the parties; and

**WHEREAS**, the parties wish to enter into a Shared Services Agreement under the parameters of the Act whereby the City of Paterson shall provide Tuberculosis Control Services to the Township of Wayne for a twelve (12) month period from January 1, 2018 through December 31, 2018 at a cost of \$1,600.00; and

**WHEREAS**, the City of Paterson has authorized this Agreement pursuant to Resolution #18:415 adopted on July 17, 2018; and

**WHEREAS**, funds are available in Account No. 8-01-27-786-114 or any other account that may be deemed appropriate by the Chief Financial Officer or her designee, and the availability of funds has been certified by the Chief Financial Officer; and

**WHEREAS**, the Health Officer has reviewed the Agreement and recommends the terms contained therein.

**NOW, THEREFORE, BE IT RESOLVED** by the Municipal Council of the Township of Wayne that the Mayor and Township Clerk, Health Officer, or any other Township Official as may be deemed appropriate, are hereby authorized to execute a Shared Services Agreement with the City of Paterson Department of Health and Human Services, Division of Health for the furnishing of Tuberculosis Control Services in a sum not to exceed \$1,600.00 for the term of January 1, 2018 through December 31, 2018, a copy of said Agreement being on file in the Office of the Township Clerk and hereby approved; and

**BE IT FURTHER RESOLVED** that this expenditure shall be charged to Account No. 8-01-27-786-114 or any other account that may be deemed appropriate by the Chief Financial Officer or her designee, and the availability of funds has been certified by the Chief Financial Officer; and

**BE IT FURTHER RESOLVED** that a certified copy of this Resolution shall be forwarded to the Clerk of the City of Paterson; and

**BE IT FURTHER RESOLVED** that a copy of the Agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs.
