RESOLUTION TO ENTER INTO AN INTERLOCAL SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF EGG HARBOR AND THE TOWNSHIP OF UPPER FOR THE USE OF FACILITIES, EQUIPMENT AND SUPPLIES FOR TRUCK AND EQUIPMENT WASHING

Whereas, the Township of Egg Harbor has requested that an agreement be entered with the Township of Upper for the use of facilities, equipment and supplies for truck and equipment washing; and

Whereas, said agreement will allow the Township of Egg Harbor the use of the facilities, equipment and supplies for truck and equipment washing at the discretion of the Township of Upper; and

Whereas, attached is the Shared Services Agreement between the Township of Upper and the Township of Egg Harbor; and

Whereas, the agreement shall be for a term of one (1) year and commence upon the execution of a shared services agreement between the municipalities, unless otherwise agreed to by the parties, either party giving thirty (30) days advance written notice to their intention to terminate; and


Whereas, the Township of Egg Harbor shall pay the following rates:

- a) Class B Refuse trucks shall be at a rate of \$55 per truck;
- b) All other vehicles & equipment shall be at a rate of \$45 per piece.

Now, therefore, be it resolved, by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey, that it does hereby accept and support this agreement; and

Be it further resolved, that the Mayor and Township Clerk are hereby authorized to execute the agreement between the Township of Upper and the Township of Egg Harbor.

**RE: AUTHORIZING A SHARED SERVICES AGREEMENT WITH THE TOWNSHIP
OF EGG HARBOR FOR USE OF FACILITIES, EQUIPMENT AND SUPPLIES FOR
TRUCK AND EQUIPMENT WASHING**

WHEREAS, on August 1, 2012 the Township of Upper and the Township of Egg Harbor entered into a Shared Services Agreement for use of facilities, equipment and supplies for truck and equipment washing which has now expired; and

WHEREAS, the Township of Upper and the Township of Egg Harbor desire a new Agreement for an additional one year; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee, the governing body of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.
2. The Township Committee hereby authorizes a Shared Services Agreement with the Township of Egg Harbor for use of facilities, equipment and supplies for truck and equipment washing for one (1) year, commencing August 1, 2015 and expiring on July 31, 2016.
3. This Resolution extending the terms of the aforesaid Shared Services Agreement is conditioned upon similar action being taken by the Township of Egg Harbor.
4. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.

Shared Services Agreement
For
Use of the Facilities, Equipment and Supplies for Truck and

THIS AGREEMENT, made this 7th day of Oct, 2015, between the TOWNSHIP OF UPPER (hereinafter referred to as "Upper Township"), whose address is 2100 Tuckahoe Road, Petersburg, NJ 08270 and the Township of Egg harbor (hereinafter referred to as "Egg Harbor Township"), whose address is 3515 Bargaintown Road, Egg Harbor Township, NJ 08234.

WITNESSETH

WHEREAS, Egg Harbor Township owns various pieces vehicles and equipment that are required to be cleaned from time to time; and

WHEREAS, Egg Harbor Township does not have a facility for washing said vehicles that comply with the New Jersey Department of Environmental Protection's Stormwater Permit requirements; and

WHEREAS, Upper Township has constructed a vehicle wash facility (hereinafter referred as "the facility") at their Public Works Yard located at 1691 Mt. Pleasant-Tuckahoe Road in Tuckahoe that complies with the New Jersey Department of Environmental Protection's Stormwater Permit requirements; and

WHEREAS, the Uniform Shared Services Act (N.J.S.A. 40A:65-1, et seq.) authorizes and empowers Upper Township and Egg Harbor Township to enter into this Agreement.

NOW, THEREFORE, it is agreed, stipulated and understood between the parties, in consideration of the mutual promises contained herein, as follows.
