WHEREAS, the aforementioned Agreement provides for extensions from year-to-year by mutual agreement and resolution of both municipalities, with the last renewal to expire no later than December 31, 2018; and

WHEREAS, by Resolution No. 790-16, adopted on October 19, 2016, the Governing Body authorized a one-year contract extension which will expire on December 31, 2017; and

WHEREAS, the Governing Body now deems it to be in the best interests of the Borough of Wildwood Crest to exercise a final one-year extension which will expire on December 31, 2018.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Borough of Wildwood Crest, in the County of Cape May and State of New Jersey, as follows:


- 1) All of the statements of the preamble are repeated and incorporated herein by this reference thereto as though the same were set forth at length.

RESOLUTION

EXERCISING OPTION TO EXTEND FOR ONE-YEAR SHARED SERVICES AGREEMENT WITH THE BOROUGH OF WILDWOOD CREST FOR MUNICIPAL COURT ADMINISTRATOR

WHEREAS, by Resolution #160-15, adopted July 21, 2015, the City Council of the City of North Wildwood authorized the Mayor and City Clerk to enter into a Shared Services Agreement with the Borough of Wildwood Crest for a Municipal Court Administrator; and

WHEREAS, the aforementioned Agreement expired on December 31, 2016; and

WHEREAS, the aforementioned Agreement provides for extensions from year-to-year by mutual agreement and resolution of both municipalities, with the last renewal to expire no later than December 31, 2018; and

WHEREAS, by Resolution #206-16, adopted October 18, 2016, Council exercised the first of the two available one-year options, extending the agreement until December 31, 2017; and

WHEREAS, Council now deems it to be in the best interests of the City of North Wildwood to exercise a one-year extension to expire on December 31, 2018.


