
WHEREAS, the Township of Upper desires to extend the term of said Agreement, as stipulated therein, for an additional six years; and

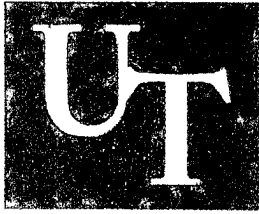
1. The allegations of the preamble are incorporated herein by this reference.
