SHARED SERVICES AGREEMENT PURSUANT TO N.J.S.A. 40A:65-1 ET SEQ.
BETWEEN THE BOROUGH OF HARRINGTON PARK AND THE BOROUGH OF
HAWORTH, COUNTY OF BERGEN, NEW JERSEY

Whereas the Borough of Harrington Park and the Borough of Haworth would each and for their individual and mutual benefit enter a Shared Services Agreement pursuant to N.J.S.A. 40A:65-1 et seq. allowing for the cooperative use by each of the parties of the personnel and machinery of the other for the purpose of eliminating redundancy, promoting efficiency and for cost saving purposes;

Whereas the Borough of Harrington Park is desirous of obtaining the following services from the Borough of Haworth, subject to its availability:

1. The Harrington Park DPW wishes to use a certain Elgin Street Sweeper while the Borough of Haworth awaits delivery of its new Street Sweeper.

2. When the Borough of Haworth takes delivery of its new Street Sweeper, the Borough of Harrington Park shall purchase from the Borough of Haworth its current Elgin Street Sweeper for the sum of \$12,000 payable by the Borough of Harrington Park upon delivery.

Duration of the agreement -The term of this agreement shall be for one year and unless either party specifically cancels the agreement within 30 days of the anniversary date of such agreement.


Dispute Resolution -In the event of any dispute between the parties concerning the terms and conditions of this agreement shall be submitted to binding arbitration before a retired Superior Court Judge of the State of New Jersey, Bergen County vicinage as appointed by the Presiding Civil Assignment Judge of the County of Bergen, such appointed Arbitrator shall review the dispute and render a decision within 30 days of his appointment. The parties agree to share equally in the cost and expense of such arbitration.

Costs-Any costs or expenses incurred in the implementation of this agreement which may be assessed against either party shall be rendered by way of submission of a voucher to the assessed party which voucher shall be processed and paid within 30 days of submission.

Municipal Consent -Each party hereto shall by appropriate Resolution agree, adopt and authorize the execution of this contract and the terms contained therein.


Severability- In the event any provision of this Agreement is stricken or of no force and effect then all other provisions shall remain in full force and effect.


