
RE: AUTHORIZING AN AMENDMENT TO THE SHARED SERVICES

TRUCK AND EQUIPMENT WASHING


WHEREAS, on August 1, 2012 the Township of Upper and the Township of Egg Harbor entered into a Shared Services Agreement for use of facilities, equipment and supplies for truck and equipment washing; and

WHEREAS, the Township of Upper and the Township of Egg Harbor desire to extend the terms of the Agreement for an additional one year; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee, the governing body of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.
2. The Township Committee hereby authorizes the Mayor and Township Clerk to sign an Amendment to the Shared Services Agreement with the Township of Egg Harbor to extend the term of said agreement for an additional one (1) year.
3. All Township officials and officers are hereby authorized and empowered to take all action deemed necessary or advisable to carry into effect the intent and purpose of this Resolution.

**AMENDMENT TO SHARED SERVICES AGREEMENT BETWEEN THE  
TOWNSHIP OF UPPER AND THE UPPER TOWNSHIP BOARD OF  
EDUCATION FOR MAINTENANCE, REPAIRS AND USE OF FACILITIES**

**WHEREAS**, the Township of Upper and the Township of Egg Harbor have entered into a Shared Services Agreement dated August 1, 2012 for use of facilities, equipment and supplies for equipment and truck washing pursuant to Upper Township Resolution No. 135-2012 and Egg Harbor Township Resolution No. 288; and

**WHEREAS**, the parties have agreed to amend the existing Shared Services Agreement pursuant to the terms set forth herein.

**NOW, THEREFORE, IT IS AGREED AS FOLLOWS:**


1. Section 2 of the original Agreement is replaced in its entirety with the following:

2. This Agreement shall be for a term of ONE (1) YEAR from the date of full execution. The term shall be extendable for an additional one year upon resolution of both parties. Either party may cancel this Agreement upon 60 days' written notice to the other.

2. This Amendment is intended to alter and amend the existing provisions of the original Agreement. Unless expressly contradicted or amended by this document, the original terms and provisions of the Agreement remain in full force and effect. However, in the event there is any contradiction in the terms of the original Agreement and this Amendment, the terms of this Amendment shall supersede and control over the original Agreement.
